1.0 Call to order

4.0 Special Presentations:

Todd Warden from AQMD was scheduled, but unable to attend due to illness. Schulty shared an email received from him regarding upgrading the AQMD station

5.0 Community Reports

USFS: Marc Stamer gave an update of Forest Service issues, including staffing levels. He discussed the fire restrictions currently in place. Fires at designated campgrounds in fire pits are allowed. Stamer answered several questions from the audience.

SB County Sheriff: Capt. Gregory discussed a recent incident in Lake Arrowhead regarding a terrorist threat at Lake Arrowhead Village. He was very pleased with the way the Sheriff's Department handled the incident. Twin Peaks is fully staffed. Arrests are up. Captain Gregory introduced Detective Eric Trujillo. Trujillo discussed the Lake Gregory Coffee shop and its announced plan to operate as a cannabis lounge for users of marijuana. He discussed the protocol to deal with this. San Bernardino County Council is exploring the codes already in existence. The Blazing Bear, the name of the cannabis facility, received a Notice of Violation from Code Enforcement. The bike rodeo went well with over 70 kids. They gave away 28 bikes. Captain Gregory answered questions from the public.

CHP: Lt. Preszler also discussed the bicycle rodeo as well as Coffee With a Cop. The Every 15 Minutes program was a big success at both Big Bear High & Rim High. It was very emotional for the students. He will have 2 new officers by June 16th. They will be in training until late September or early October. He has not heard anything regarding Jamboree Days, but he anticipates a road closure on the 1st. Lake Arrowhead Marina and ALA are contracting for extra traffic control on the 4th weekend. Lots of extra officers will be on duty for 4th of July weekend. They have been noticing an increase in motorcycles in the mountains. There have been 2 pursuits in past 2 weeks.

6.0 Discussion Items

Lake Gregory Update: Rick Dinon

The LGIC met today. There have been lots of compliments regarding the condition of the swim beach. There are ongoing discussions with the Department of Safety of Dams and the County is making good progress on the dam permits. Should start around spring. Army Corps of Engineering is the last permit. Cal Parks had an excellent weekend. Good fishing tournament. San Moritz Way will be widened to two lanes as an alternate route during construction.

7.0 Supervisor's Report

Lewis Murray discussed approval by the Board of Supervisors of the revised Short Term Rental ordinance. There will be a 24-hour hotline available for calls relating to short term rentals. He also discussed the issue related to airplanes headed for Ontario being re-routed over the mountains, approval by the Planning Commission of Sky Park, and winter snow play clean up.

Dinon mentioned that the Lake Gregory Yacht Club had a grand opening event and many visitors commented on how beautiful Lake Gregory looked.
