Kathleen Opliger: County Fire. There is a plan to bring back the MAST (Mountain Area Safety Task Force). County fire is looking to extend Deer Lodge Park fuel break. NRCS funding may be available. Fire Station 91 will be receiving a facelift over the next few months. Unfortunately they will need to remove several cedar trees in the process. May 12 will be a special meeting at Crest Forest Fire District to consider annexation with County fire. She discussed the recent fire in Crestline that burned 3 homes.
