MEETING MINUTES

Wednesday, June 6, 2018 6:30 p.m.

- 1.0 CALL TO ORDER AND PLEDGE OF ALLEGIANCE TO THE FLAG:** The meeting was called to order at 6:05 pm by LAMAC Chair Scott Rindenow.
- 2.0 INTRODUCTION OF MAC MEMBERS:** MAC Members introduced themselves. The following board members were present: LAMAC: Scott Rindenow, Michelle Ambrozic, Voni Saxbury, Duane Banner, & Ken Stowe. CFMAC: Gil Flores, Connie Bracher, Rick Dinon, and Kyle Schulty.
- 3.0 APPROVAL OF MINUTES of the Combined MAC meeting of May 1, 2018:** Motion to approve by Voni Saxbury. Seconded by Rick Dinon. Approved 9/0/0 with the following corrections: Last name for Caleb from Rock Force construction was added (Reynoldson). On the line referenceing the CHP report, "in" was changed to "is." In addition the letter "a" was removed between "same" and "as." Karen reams was changed to Karen Reams. "Update" was changed to "updated." And under the Supervisor's report "disusses" was changed to "discussed."
- 4.0 SPECIAL PRESENTATIONS:**
 - a. Sheriff John McMahan**
Sheriff McMahan gave a presentation on the status of the San Bernardino County Sheriff's Department. He discussed staffing levels and challenges due to recent legislation.
- 5.0 DISCUSSION ITEMS:**

Crest Forest MAC Discussion Items:

 - a. Lake Gregory Improvement Committee, Status of Dam Repairs, Rockforce Construction:**
Caleb Reynoldson stated that construction is ahead of schedule. There is currently traffic control occurring in the vicinity of the dam. Large excavating equipment will be staged in the next few weeks.
 - b. California Parks, Lake Gregory Regional Park: Arlene Arenas:**
Arlene shared upcoming events and activities at the park. She encourage people to follow their Facebook page and website for news and updates.

Lake Arrowhead MAC Discussion items

 - a. Lake Arrowhead Village, Vikki Goodglick:**
Vikki discussed the Summer Concert Series; all dates are set. She also discussed the Farmer's Market. She answered questions regarding the status of the Village.
 - b. Arrowhead Lake Association, Wayne Austin:** The ALA is busy launching boats, planning for events, setting up and launching their new website, stocking fish, and repairing trails. They will have a dedication at their office building as well as a dedication of the County Fire Boat in June.

6.0 REPORTS:

- a. **Invited: Crestline, Lake Arrowhead, & Running Springs Chambers of Commerce updates:**

Louis Boehle, Crestline Chamber of Commerce, discussed their 2018 marketing program. There are multiple events and activities planned. Artisan Alley, Corks & Hops, Jamboree Days, and a possible Top Town Party. Other things are in the planning stages.

Robin Bull, Lake Arrowhead Chamber of Commerce, discussed their current marketing program. Two billboards are up with more to come. Promoting new website. Working on improving communication with the community via an electronic weekly newsletter.
- b. **Representatives of Elected Officials (Congressman Cook, Senator Morrell, Assemblyman Obernolte)**

Josh Imeri-Garcia, Congressman Cook's Office, shared an update on the air traffic over Lake Arrowhead issue. Shannon Hinkle, Assemblyman Obernolte's Office, shared several bills of concern to the Assemblyman. She also discussed the possible repeal of the gas tax.
- c. **Government Agencies:**
 - **San Bernardino County Sheriff:** Gil Flores stated that deputies are doing a great job in the community. They recently arrested an individual responsible for multiple daytime burglaries. The Sheriff's bicycle rodeo is coming up next week.
 - **California Highway Patrol:** Commander Tony Coronado said vehicle theft is on the decrease in the mountains. Be careful what you leave in your car. He discussed marijuana use and driving. Having it in your possession is the same as an open container. They will have increased patrols during the 4th of July holiday.
 - **San Bernardino County Fire:** Battalion Chief Bob Evans discussed the purchase of a new ambulance that will be assigned to Station 94 on North Bay and Peninsula. He also discussed upcoming chipper days.
 - **Cal Fire:** Division Chief Jeff Veik discussed the impacts of bark beetles and areas that are experiencing high mortality. They have two fuel reduction projects in the area; Sawmill Road in Twin Peaks and the Cedar Glen Boy Scout Camp.
 - **US Forest Service:** Zach Behrens & Marc Stamer discussed pile burning currently occurring. They also discussed fuels reduction projects, recreation, permits, and bringing on seasonal employees. Campgrounds are open.
- d. **Community Agencies:**
 - **Rim of the World Recreation & Park District:** Karen Reams gave an update on the Lake Gregory facility that recently opened. She discussed classes being offered. She also updated the community on the ATP Grant, 4th of July at MacKay Park, and the Run through the Pines.
- e. **Supervisor's Report**
 - **Lewis Murray:** Lewis thanked Lake Gregory Recreation Company for the use of the San Moritz Lodge. He discussed weed abatement, short-term rentals, and air traffic over Lake Arrowhead.

7.0 PUBLIC COMMENT:

MACs receive comments on non-agenda items. Public comment is limited to three minutes per item per person. Limitations during Public Comment are at the discretion of the MAC Chairperson. Items discussed included Rim School District, Alpenhorn news, and polling oversight.
