- Create an assisted ally action plan to implement in their work with the goal of inclusion and nondiscriminating service to LGBTQ community members that can be readily applied.

The training is intended to assist service workers and professionals with culturally competent information geared toward reducing stigma of the LGBTQ community in order to serve the community in the most competent manner. With the development of this training we hope to gather resources for the development of a community resource guide that will increase access to culturally appropriate services within the community and the Department of Behavioral Health.
