- ⇒ Distinguish new state laws affecting behavioral health providers and other medical-legal issues in the news in 2016 including medical marijuana, assisted dying, opiate dependence and the role of the medical profession;
- ⇒ Identify federal laws affecting behavioral health providers including an update efforts and legislation to permit more flexible sharing of mental health and substance use disorder information;
- ⇒ Discuss review of consent and minor consent laws in California and how those laws impact control of the record and access to information;
- ⇒ Analyze a review of HIPAA and basic state and federal confidentiality rules, including differences between rules for sharing mental health vs. substance use disorder records amongst care providers to support collaborative care;
- ⇒ Identify confidentiality and mandated reporting duties: child abuse/neglect, elder and dependent adult abuse/neglect and Tarasoff Duty to Warn;
- ⇒ Assess ethical dilemmas including dual relationships and boundary issues, and how professionalism supports the integrity of a healthcare team and the care a patient receives.
