Course Description:

SAN BERNARDINO COUNTY

The purpose of this full-day training is to provide participants with a detailed overview of medications that have been shown to be effective as a component of the treatment of alcohol and opioid addiction. Topics will include: the context for medication-assisted treatment (positive and negative perceptions), the epidemiology of alcohol and opioid dependence (user demographics), a review of alcohol and the various classes of opioids, an overview of each medication, its indication, to whom it is administered, and how it works, and treatment settings for medication-assisted treatment.

Objectives:

- 1. Describe at least three (3) acute and chronic effects of alcohol and opioids.
- 2. Describe the prevalence of and key populations impacted by alcohol and opioids use, abuse, and dependence.
- 3. Provide examples of at least two (2) medications that are available to treat alcohol and opioid addiction.
- 4. List and explain at least two strategies that can be used to address health disparities through access to medication-assisted treatment.
