CHAIRPERSON'S REPORT

Chairperson Susan McGee-Stehsel recognized Dr. Roberto Casas, former Behavioral Health Commissioner, for his many contributions to the BHC and to the residents of the Fourth District during his appointment from 2009-2014.

COMMISSIONERS' REPORTS

First District:

Commissioner Mike Grabhorn stated that Mourning Star, Visiting Nurse Association, is a nationally-acclaimed support center for grieving children, teens and their families. Due to an increase in liver damage, the Food and Drug Administration now recommends health care professionals discontinue prescribing prescription combination drug products that contain more than 325 milligrams (mg) of acetaminophen. It is also recommended to reduce the strength of prescription opiates.

Second District:

In honor of African American Mental Health Awareness Week, Commissioner May Farr attended the "Breaking the Silence" Seminar on 2/11/14. During the February District Advisory Committee meeting, Terrance Stone, Young Visionaries, presented the SMART Team program, which mentors African American youth in schools. She also attended the grand opening of the Vintage at Kendall MHSA Housing project.

Commissioner Monica Alonso announced that Upland Community Counseling and Amazing Place Clubhouse will be moving to a new site that includes more space. She also welcomed Chris Morton, new Peer & Family Advocate. The MHSA Integration plan will include real stories of clients that have utilized DBH services. Monica will share her story.

Third District:

Commissioner Chris Massa acknowledged the beautiful consumer artwork in the Auditorium. Meeting objectives were discussed at the last Alcohol and Drug Taskforce. Lauretta Ross is teaching Leadership classes at the Clubhouses. TEA House has planned an outing to the Hollywood Wax Museum.

Commissioner Mondragon expressed his condolences to the family of Gabe Gonzales, and shared that Gabe had a gift of peace and a powerful spirit that drew people to him. He reminded everyone to wear lime green throughout May Mental Health as well as Mental Health Solidarity Day on the first Tuesday in May. Cal State will soon have NAMI on campus.

Fourth District:

Secretary Akin Merino attended the 8th Annual State of Women conference in Rialto, hosted by Mayor Deborah Robertson; women of character, courage and commitment were celebrated. She congratulated DBH for a speedy intervention and placement of a homeless woman with addiction into the Therapeutic Alliance Program.

Commissioner Carol Grisotti will be attending the Gathering on Mental Health and the Church in Lake Forest, CA, on 3/28/14, from 8:30-9pm. This event is designed to encourage individuals living with mental illness, educate family members and equip church leaders to provide effective and compassionate care to those facing the challenges of mental illness.

Fifth District:

Treasurer Veatrice Jews attended the San Bernardino County Association of African American Employees Black History Month Scholarship Recognition Celebration on 2/27/14. She also attended the State of the County event to hear the county's message. She's been working with Covered California to help get individuals enrolled prior to the deadline of 3/31/14.

Board of Supervisors:

Molly Wiltshire, Communication Director for Supervisor James Ramos stated that Supervisor Ramos sends his condolences to Gabe's family. He's currently in Washington DC meeting with lawmakers. Molly looks forward to the planned activities for May Mental Health Month, as well as the Give BIG San Bernardino County Campaign, which is an effort to raise \$300,000 for local nonprofits in a 24-hour fundraising web-a-thon in May. Supervisor James Ramos spearheaded the effort to bring Give BIG to San Bernardino County, where nonprofits remain dramatically underserved.

DIRECTOR'S REPORT

Director Thomas announced the recent success of two of our Commissioners: Dr. Akin Merino has been appointed as the Vice President of Academic Affairs at Argosy University Inland Empire Campus, and Dr. Monica Wilson will be honored at the national level with a Champion of Change Award.

The Board of Supervisors adopted the 2014-15 Goals and Objectives. Key points include: grow jobs, operate in fiscally responsible manner, and maintain public safety. The Board of Supervisors are in support of the Sheriff's Department Homeless Outreach Proactive Enforcement program, which is a proactive approach to connect members of the homeless population with resources that may help them transition from homelessness.

Director Thomas discussed the Principles for Access to Medi-Cal Mental Health Coverage as determined by the CA Mental Health Director's Association: timely access, emphasis on recovery and resiliency, health equity, parity, ongoing assessment, continuity of care, person/family centered planning, flexibility/continuous quality management.

EDUCATIONAL PRESENTATION - Behavioral Health Overview Medi-Cal Expansion and Health Care Reform

Sarah Eberhardt-Rios, DBH Deputy Director, discussed the changes to behavioral health benefits in CA and explained the structure that these changes will take place in.

- DBH is a Medi-Cal HMO and takes clients who have Medi-Cal, Fee for Service Medicare, Medi-Cal/Medicare and those who are indigent or unfunded. Individuals/families with an annual income up to 138% of the Federal Poverty Level (FPL) will have Medi-Cal.
- DBH does not take clients with commercial insurance, Medicare HMO, Medicare Advantage, Medicare DSNPS or Dual Choice. Individuals/families with an annual income of 139% plus FPL will have Covered California.
- Medi-Cal beneficiaries fall into 3 categories:

- ✓ Tier 1 (usually mild symptoms) Seen by either IEHP or Molina
- ✓ Tier 2 (usually mild to moderate) Seen by either IEHP or Molina
- ✓ Tier 3 (usually significant to severe) Seen by DBH
- More adults will be eligible for Medi-Cal and other insurance, and more adults will have access to behavioral health services, care will be coordinated and data will be more integral at all levels.
