The Applicant further agrees that the Registrar of Voters, their agents and employees shall not be liable for any loss arising, directly or indirectly, in whole or in part, from any inaccuracy, mistake or error in the aforementioned information provided to the applicant or for any error, failure or delay in the transmission of any of the aforementioned information. Applicant also agrees to indemnify, defend and hold Registrar of Voters, their agents and employees harmless against any and all damages, liabilities, actions and claims which result, directly or indirectly in whole or in part, from the contents or use of the aforementioned information by the applicant, his agent or employees.

**The Applicant further agrees NOT to sell, lease or deliver possession of the registration information, or copy thereof, or any portion thereof, to any person, organization or agency without first receiving written authorization to do so from the Secretary of State or from the source agency.**

Subject to provisions of Title 2, Division 7, Article 1, Sections 19001 through 19007 of the California Administrative Code, the Applicant agrees to pay the State of California, or the source agency, as compensation for any UNAUTHORIZED USE OF EACH INDIVIDUAL'S REGISTRATION INFORMATION, an amount equal to the sum of fifty cents (\$.50) multiplied by the number of times each registration record is used by the Applicant in an unauthorized manner.
