**AGRICULTURE**

**Risk Management Education and Outreach Partnerships Program**

The purpose of this combined cooperative partnership agreements program is to deliver crop insurance education and risk management training to U.S. agricultural producers to assist them in identifying and managing production, marketing, legal, financial and human risk. The program gives priority to: (1) educating producers of crops currently not insured under Federal crop insurance, specialty crops, and underserved commodities, including livestock and forage; and (2) providing collaborative outreach and assistance programs for limited resource, socially disadvantaged and other traditionally under-served farmers and ranchers.

**Rural Cooperative Development Grant Program (RCDG)**

Rural Cooperative Development grants are made for establishing and operating centers for cooperative development for the primary purpose of improving the economic condition of rural areas through the development of new cooperatives and improving operations of existing cooperatives. The U.S. Department of Agriculture desires to encourage and stimulate the development of effective cooperative organizations in rural America as a part of its total package of rural development efforts.

**Early Education Partnerships to Expand Protective Factors for Children with Child Welfare Involvement**

The purpose of this FOA is to support school-based initiatives to implement multi-disciplinary interventions building on protective factors for children who are at risk of child abuse and neglect or are currently in the child welfare system. Applications will represent viable partnerships that include commitments from child welfare and early childhood (e.g., Head Start, Early Head Start, State Pre-K) and may involve health and mental health organizations. These 17-month infrastructure building grants will improve collaboration between early childhood and child welfare programs with the goal of maximizing the number of children involved in the child welfare system who are enrolled in early childhood programs.

The purpose of this FOA is to support demonstration projects that test the effectiveness of family group decision-making as a service approach that prevents children from entering foster care, thereby reducing the time that these children and families are involved with the child welfare system. Projects will engage families in building protective factors and reducing risk factors for children and families, and will address related domestic violence, mental health, and substance abuse issues.

America's Historical and Cultural Organizations grants support projects in the humanities that explore stories, ideas, and beliefs in order to deepen our understanding of our lives and our world. The Division of Public Programs supports the development of humanities content and interactivity that excite, inform, and stir thoughtful reflection upon culture, identity, and history in creative and new ways. Grants for America's Historical and Cultural Organizations should encourage dialogue, discussion, and civic engagement, and they should foster learning among people of all ages. To that end, the Division of Public Programs urges applicants to consider more than one format for presenting humanities ideas to the public. NEH offers two categories of grants for America's Historical and Cultural Organizations: planning and implementation grants. Planning grants are available for projects that may need further development before applying for implementation. This planning can include the identification and refinement of the project's main humanities ideas and questions, consultation with scholars, preliminary audience evaluation, preliminary design of the proposed interpretive formats, beta testing of digital formats, development of complementary programming, research, or the drafting of interpretive materials. Implementation grants support the final preparation of a project for presentation to the public. See application guidelines for Implementation Grants. Applicants must submit a full walkthrough for an exhibition, or a prototype or storyboard for a digital project that demonstrates a solid command of the humanities ideas and scholarship that relate to the subject. Applicants for implementation grants should have already finished most of the planning for their projects, including the identification of the key humanities themes, relevant scholarship, and program formats. For exhibitions, implementation grants can support the final stages of design development, but these grants are primarily intended for installation.

**America's Media Makers Grants**

Grants for America's Media Makers support projects in the humanities that explore stories, ideas, and beliefs in order to deepen our understanding of our lives and our world. The Division of Public Programs supports the development of humanities content and interactivity that excite, inform, and stir thoughtful reflection upon culture, identity, and history in creative and new ways. Grants for America's Media Makers should encourage dialogue, discussion, and civic engagement, and they should foster learning among people of all ages. To that end, the Division of Public Programs urges applicants to consider more than one format for presenting humanities ideas to the public. NEH offers two categories of grants for media projects: development grants and production grants. Development grants enable media producers to collaborate with scholars to develop humanities content and format and to prepare programs for

production. Development grants should culminate in the refinement of a project's humanities ideas, a script, or a design document for (or a prototype of) digital media components or projects, or a prototype for a digital media project together with a detailed plan for outreach and public engagement in collaboration with partner organizations. See application guidelines for Development Grants. Production grants support the preparation of a program for distribution. Applicants must submit a script for a radio or television program, or a prototype or storyboard for a digital media project, that demonstrates a solid command of the humanities ideas and scholarship related to a subject. The script for a radio or television program, or prototype or storyboard for a digital media project, must also show how the narrative elements, visual approach, and interactive design combine to present the project's humanities ideas. Applicants must have consulted with appropriate scholars about the project and obtained their commitment as advisers. Finally, applicants must have recruited the media team, including at a minimum the producer, director, writer, and, for a digital media project, the interactive designer.

### **Gateway to College National Network Offers Start Up Funding for College/K-12 Partnerships to Serve Out-Of-School Youth**

The Gateway to College National Network, a nonprofit organization supported by the Bill & Melinda Gates Foundation and other major grantmakers, has funds available for partnerships between colleges and K-12 school districts to implement the Gateway to College dropout recovery program. The GtC National Network works to build the capacity of colleges, school districts, and states to revolutionize education for high school dropouts and underprepared college students so that all young people can achieve college credentials. The nationally recognized dual-credit program serves youth (ages 16 to 21) who have dropped out of school or are significantly behind in credits and unlikely to graduate. GtC classes are taught on the college campus. After completing a program of developmental skills courses in a learning community of their peers, students transition to regular college classes where they continue working toward their high school diploma and, simultaneously, an associate's degree. The initial start-up funding from GtCNN pays for planning and early implementation costs. The programs are then funded through formal partnerships between colleges and school districts. K-12 districts provide funds on a per-pupil basis to cover the cost of tuition, books, and support staff. Colleges can work with multiple school district partners.

### **Susan Harwood Training Grant Program FY 2011**

The U.S. Department of Labor (DOL), Occupational Safety and Health Administration (OSHA) awards funds to nonprofit organizations to provide training and educational programs for workers and/or employers. Nonprofit organizations, including qualifying labor unions, community-based and faith-based organizations and employer associations, that are not an agency of a state or local government, are eligible to apply. Additionally, state or local government-supported institutions of higher education are eligible to apply in accordance with 29 CFR Part 95. ### **Public Television Digital Transition Grant Program**

As part of the nation's transition to digital television, the Federal Communications Commission (FCC) required all television broadcasters to have converted their transmitters to broadcast digital signals by June 12, 2009. While stations must broadcast their main transmitter signal in digital, many rural stations have yet to complete a full digital transition of their stations across all equipment. Rural stations often have translators serving small or isolated areas and some of these have not completed the transition to digital. Some rural stations also have not fully converted their production and studio equipment to digital. Grant funds may be used to acquire and install facilities and software necessary for the transition as well as equipment to facilitate local origination and management of programming. Grant funds may also be used for associated engineering and environmental studies. The program is targeted at public television stations that serve rural areas.

### **Brownfield Economic Development Initiative (BEDI)**

BEDI funds are used to enhance the security of a loan guaranteed by HUD under Section 108 of the Housing and Community Development Act of 1974, as amended, for the same brownfields economic development project, or to improve the viability of a brownfields economic development project financed with the Section 108-guaranteed loan, in order to stimulate economic development by local governments and private sector parties at brownfields sites and to return those sites to productive economic use. All BEDI grants must be used in conjunction with a new Section 108-guaranteed loan commitment. HUD encourages brownfields economic development projects that propose the redevelopment of a brownfield site through new investments by identified private sector parties in addition to BEDI/Section 108 financing and projects that will directly result in new business or job creation, increases in the local tax base or other near-term, measurable economic benefits. BEDI is designed to help local governments redevelop brownfields, defined in this NOFA as abandoned, idled, or underutilized real property, including industrial and commercial facilities, where expansion or redevelopment is complicated by the presence or potential presence of environmental contamination. A BEDI grant award will be conditioned upon, and must be used in conjunction with, a new (i.e., not previously approved) Section 108-guaranteed loan commitment. Both Section 108 loan guarantee proceeds and BEDI grant funds are initially made available by HUD to units of general local government eligible for assistance under HUD's Community Development Block Grant (CDBG) program.

### **Water and Waste Revolving Fund Grants**

Drinking water systems are basic and vital to both health and economic development. With dependable water facilities, rural communities can attract families and businesses that will invest in the community and improve the quality of life for all residents. Without dependable water facilities, the communities cannot sustain economic development. Rural Development provides financial and technical assistance to help communities bring safe drinking water and sanitary, environmentally sound waste disposal facilities to rural Americans in greatest need. It supports the sound development of rural communities and the growth of our economy without endangering the environment. The Revolving Fund (RFP) Grant Program has been established to assist communities with water or wastewater systems. Qualified private non-profit organizations will receive RFP grant funds to establish a lending program for eligible entities. Eligible entities for the revolving loan fund will be the same entities eligible to obtain a loan, loan guarantee, or grant from the Water and Waste Disposal loan and grant programs administered by Rural Development. As grant recipients, the non-profit organizations will set up a revolving loan fund to provide loans to finance predevelopment costs of water or wastewater projects, or short-term small capital projects not part of the regular operation and maintenance of current water and wastewater systems. The amount of financing to an eligible entity shall not exceed \$100,000.00 and shall be repaid in a term not to exceed 10 years. The interest rate on loans made under RFP shall be determined in the approved grant work plan.

#### **WaterSMART Applied Science Grants for the Desert Landscape Conservation Cooperative**

#### **Water Sustainability and Climate**

The goal of the Water Sustainability and Climate (WSC) solicitation is to understand and predict the interactions between the water system and climate change, land use (including agriculture, managed forest and rangeland systems), the built environment, and ecosystem function and services through place-based research and integrative models. Studies of the water system using models and/or observations at specific sites singly or in combination that allow for spatial and temporal extrapolation to other regions, as well as integration across the different processes in that system are encouraged, especially to the extent that they advance the development of theoretical frameworks and predictive understanding. Specific topics of interest include:\* Developing theoretical frameworks and models that incorporate the linkages and feedbacks among atmospheric, terrestrial, aquatic, oceanic, and social processes that can be used to predict the potential impact of (1) climate variability and change, (2) land use and (3) human activity on water systems on decadal to centennial scales in order to provide a basis for adaptive management of water resources.\* Determining the inputs, outputs, and potential changes in water budgets and water quality in response to (1) climate variability and change, (2) land use and (3) human activity, and the effect of these changes on Biogeochemical cycles, water quality, long-term chemical transport and transformation, terrestrial, aquatic and coastal ecosystems, landscape evolution and human settlements and behavior.\* Determining how our built water systems and our governance systems can be made more reliable, resilient and sustainable to meet diverse and often conflicting needs, such as minimizing consumption of water for energy generation, industrial and agricultural/forest rangeland production and built environment requirements, reuse for both potable and non-potable needs, ecosystem protection, and flood control and storm water management. This activity enables interagency cooperation on one of the most pressing problems of the millennium--water sustainability --how it is likely to affect our world, and how we can proactively plan for its consequences.

### **Sustainable Comprehensive Tobacco Cessation and Prevention Clinical Program for Low Socio-economic Status Women of Childbearing Age - FY11**

The purpose of this project is to implement and to evaluate the success of tobacco cessation and prevention programs in selected Federal Clinical Partners to address tobacco use among LSES women of childbearing age. The Federal Clinical Partners are the Health Resources and Services Administration (HRSA) and/or Indian Health Service (IHS) federally-funded healthcare clinics, and/or Medicaid-reimbursed providers. Successful applicants will design tobacco cessation and prevention programs to be implemented in the Federal Clinical Partners organizations that: 1. Are based on Treating Tobacco Use and Dependence, Clinical Practice Guideline, 2008 Update (Public Health Service Guideline); 2. Employ implementation process steps that will ensure project sustainability after the grant period ends for the Federal Clinical Partners; 3. Ensure that a certified tobacco specialist uses the 5As (Ask, Advise, Assess, Assist, Arrange; see the Public Health Service Guideline for detailed information) with every patient; 4. Ensure LSES women of childbearing age identified as tobacco users are offered brief intervention, counseling, follow-up, and other cessation services listed in the Public Health Service Guideline; and, 5. Demonstrate increased quit attempts, abstinence, and/or cessation for LSES women of childbearing age using the services of the Federal Clinical Partners.
