The Vodafone Americas Foundation and mHealth Alliance have announced a call for submissions for the annual Vodafone Americas Foundation Wireless Innovation Project and the mHealth Alliance Award, which recognizes wireless-related technologies with the potential to solve critical global problems. The applicant should propose an innovation in wireless-related technology that addresses a critical global issue in education, health, access to communication, the environment, and/or economic development. The project should demonstrate a significant advancement in wireless-related technology, potential for replication and large-scale impact, and be at a stage of research where an advanced prototype or field/market test can occur during the award period. Early-stage research or ready-to-launch products will not be considered. Proposals should include a business plan or demonstration of financial sustainability.

Job Opportunity for Low Income Individuals Projects

The Office of Community Services' (OCS) will award up to \$1.16 million through the Job Opportunity for Low-Income Individuals (JOLI) program to support business development and expansion opportunities, including micro-enterprise and self-employment opportunities, in an effort to help Temporary Assistance for Needy Families (TANF) recipients and other low-income individuals achieve economic self-sufficiency. JOLI grantees create jobs through provision of technical and financial assistance to private employers in the community in order to create sustainable employment and business opportunities. Financial assistance to low-income individuals may be provided through the use of revolving loan funds or the provision of direct cash assistance to a micro-enterprise or self-employed business owner. Funded projects should focus on one of the following three program strategies: (1) new business ventures, (2) business expansion, and (3) self-employment/micro-enterprise projects.

Funds are granted for charitable, scientific, literary or educational purposes or for the identification, ongoing evaluation and education of and services for children and adults with learning disabilities. With the exception of LDA committed funds, grants will not be made for routine organizational operations or for endowment funds. Funds will be awarded only to non-profit organizations and educational institutions which are exempt from taxation under Section 501(c)(3) of the Internal Revenue Code

National Urban and Community Forestry Challenge Cost-Share Grant Program Urban Forest Innovation Grants Funding Opportunity Request for Pre-Proposals The U.S. Forest Service anticipates that the statutory authority for the Fiscal Year 2012 Urban and Community Forestry (U&CF) Program will provide, under the Cooperative Forestry Assistance Act (Section 9), approximately \$900,000 in grant funds to be awarded through the 2012 National Urban and Community Forestry Challenge Cost-Share Grant Program. Funds are to support urban and community forestry projects on nonfederal public land that have a national or widespread impact and application. All awards are based on the availability of funding, which may be subject to change.

Viral Hepatitis Surveillance

The program will support active, enhanced surveillance to monitor the burden of acute and chronic viral hepatitis disease through core surveillance of acute hepatitis A, B, C, and chronic hepatitis B and C. This program addresses the "Healthy People 2020" focus area(s) of Immunization and Infectious Diseases: - IID-1.3 Reduce, eliminate, or maintain elimination new hepatitis B cases among persons 2 to 18 years; - IID-15 Increase hepatitis B vaccine coverage among high-risk populations; - IID-25.1 Reduce hepatitis B infections in adults aged 19 and older; - IID-25.2 Reduce hepatitis B infections among high risk populations - injection drug users; - IID-25.3 Reduce hepatitis B infections among high risk populations - men who have sex with men; - IID-26 Reduce new hepatitis C infections; and - IID-27 Increase the percentage of persons aware they have hepatitis C infection.

Cardinal Health Foundation Invites U.S. Healthcare Providers to Apply for Grants to Improve Patient Safety

The Cardinal Health Foundation has announced that, for the fifth consecutive year, it will award more than \$1 million in grants through its E3 - Effectiveness, Efficiency, and Excellence in Healthcare Program to help hospitals, health systems, community health clinics, and other nonprofit healthcare institutions in the United States improve the efficiency and quality of patient care. Applicants are encouraged to submit funding requests for projects that help improve medication safety, particularly for periods when patients move from hospital environments to home and other healthcare settings; or for projects that improve operating room safety through the use of World Health Organization Surgical Safety checklists. These checklists have been proven to reduce surgical morbidity and mortality by providing a list of patient safety activities that a surgical team must complete before commencing a medical procedure. In addition to receiving funding, grantees will have access to coaching and support from experts in medication safety and surgical safety checklists.

International Programs to Combat Trafficking in Persons

The Department of State's Office to Monitor and Combat Trafficking in Persons (the Office) is pleased to announce a two-stage competitive process for fiscal year 2012 funding of projects that will improve the response to trafficking in persons outside the United States. The first stage is submission and competitive panel review of two-page Statements of Interest (SOI) from organizations interested in submitting proposals for projects that combat human

trafficking. In the second stage, the Office will invite applicants whose Statements of Interest meet the technical requirements and are reviewed favorably to submit proposals that expand on their SOI. These proposals will also be reviewed by a panel for consideration of funding. This announcement initiates the first stage and the Office is now requesting applicants to submit a Statement of Interest, as described in this solicitation. U.S.-based and foreign non-profit and non-governmental organizations (NGO), public international organizations (PIO), and institutions of higher education are encouraged to apply by submitting a Statement of Interest. Pending fiscal year 2012 appropriations, the Office anticipates awarding grants of up to \$750,000 per project.

Non-Profit Boating Safety Grant Program

The Federal Boat Safety Act of 1971 [recodified under Title 46, United States Code] gave the USCG new authority to deal with the large growth in recreational boating, including new programs for boat construction standards, boat defect correction oversight, boat operator requirements, and state financial assistance. The state financial assistance program was established to promote cooperative efforts between the USCG and states' boating safety programs. The majority of the program's financial assistance funds are allocated to the states and eligible U.S. territories via a formula fixed in law. However, under the provisions of the Act 46 USC Part 131, up to 5% of the total state financial assistance available each year may be set aside for awards to eligible national nonprofit public service organizations to support National Recreational Boating Safety Program activities.
