In September 2007, the San Bernardino County Homeless Partnership (SBCHP) was formed to provide a more focused approach to our goal of ending homelessness within the County. The Partnership consists of city governments, community based organizations, faith-based organizations, educational institutes, non-profit organizations, private industry, and federal, state, and local government.

SBCHP was developed to promote a strong collaboration between agencies to direct the planning, development, and implementation of the County's 10-year-plan to end chronic homelessness. The Partnership meets on the third Wednesday of each month at the Behavioral Health Resource Center in Rialto. The Partnership facilitates better communication, planning, coordination, and cooperation among all entities that provide services and/or resources for the relief of homelessness in San Bernardino County.

Mission Statement

The Mission of the San Bernardino County Homeless Partnership is to provide a system of care that is inclusive, well planned, coordinated and evaluated and is accessible to all who are homeless and those at-risk of becoming homeless.

The focus is to make sure we are meeting the needs of placing homeless individuals and keeping in line with the 10 Year Strategy to End Homelessness. The providers will look at all avenues that will help keep finances within the Desert/Mountain region to include reaching out to community businesses and other organization that donate to the specific needs of the homeless provider population. The local Gas Company, Verizon and Edison provide donations to communities. Edison also provides free computers. This will help reduce the amount of travel time that consumers face in order to receive the appropriate services they need. ICH will be releasing an RFP that will consist of approximately \$1.2 million per year for the entire county. Each agency is encouraged to apply. Lois would like to see more involvement in working with the City of Victorville to identify their goals, determine whether providers are keeping in line with compliance issues and address how the city is representing the homeless population.
