In September 2007, the San Bernardino County Homeless Partnership (SBCHP) was formed to provide a more focused approach to our goal of ending homelessness within the County. The Partnership consists of city governments, community based organizations, faith-based organizations, educational institutes, non-profit organizations, private industry, and federal, state, and local government.

SBCHP was developed to promote a strong collaboration between agencies to direct the planning, development, and implementation of the County's 10-year-plan to end chronic homelessness. The Partnership meets on the third Wednesday of each month at the Behavioral Health Resource Center in Rialto. The Partnership facilitates better communication, planning, coordination, and cooperation among all entities that provide services and/or resources for the relief of homelessness in San Bernardino County.

Mission Statement

The Mission of the San Bernardino County Homeless Partnership is to provide a system of care that is inclusive, well planned, coordinated and evaluated and is accessible to all who are homeless and those at-risk of becoming homeless.

Regional representative will also sit on the ICH committee as the HPN representative to the Interagency Council on Homelessness. The nomination of a regional secretary is deferred to the next meeting. Tammy Dickey will assist with secretarial duties until a regional secretary is nominated. The elected secretary will also serve as the ICH representative in the event the regional representative is unable to attend. The Homeless Provider Network (HPN) second amended By-Laws were discussed and reviewed with attendees including detailed information regarding the purpose of regional meetings and how voting works. Tom shared on other regional meetings regarding issues they are facing. They are as follows: How to bring in additional funding sources, How providers can better partner with the cities How to partner with other agencies, faith based and community based organizations Reach out to local business that donate to the specific needs of the homeless provider population Establish an online resource list such as Google docs.
Discussion items	Jessica Alexander	 Jessica indicated that the shared online resource list should be a "must have" for the Central Valley Region for tracking resources and what's available. Jessica commented on the lack of support or involvement of the homeless populations in their cities and the unwillingness to work with the communities and providers. Operation Grace has reached out to the City of San Bernardino regarding building a" "homeless triage center" where individuals can receive a multitude of services under one roof.
