In September 2007, the San Bernardino County Homeless Partnership (SBCHP) was formed to provide a more focused approach to our goal of ending homelessness within the County. The Partnership consists of city governments, community based organizations, faith-based organizations, educational institutes, non-profit organizations, private industry, and federal, state, and local government.

SBCHP was developed to promote a strong collaboration between agencies to direct the planning, development, and implementation of the County's 10-year-plan to end chronic homelessness. The Partnership meets on the third Wednesday of each month at the Behavioral Health Resource Center in Rialto. The Partnership facilitates better communication, planning, coordination, and cooperation among all entities that provide services and/or resources for the relief of homelessness in San Bernardino County.

Mission Statement

The Mission of the San Bernardino County Homeless Partnership is to provide a system of care that is inclusive, well planned, coordinated and evaluated and is accessible to all who are homeless and those at-risk of becoming homeless.

Funding: How to best serve homeless individuals due to loss of funding Funding opportunities for the High Desert/local agencies	Lois Perkins/Sharon Green	 How do we bring the resources to serve the population in the high desert? Sharon reported that she has notified HUD regarding the ongoing concerns with the City of Victorville and the issuance of permits and required licenses for housing programs. Sharon is preparing a letter to the City to resolve the issues, however, any issues that are not resolved soon will be referred to Fair Housing. The City of San Jacinto faced similar housing issues which lead to litigation between the housing agencies and the City. Recommendation: Pull together as a community for a stronger presence and achievement of goals to assist homeless individuals/families with permanent housing. "One Roof, One Team". Update on New Hope Village regarding loss of funding from HUD CoC: HUD changed Permanent Housing criteria for Tier 1-New Programs. A complete explanation is not available at this time; however, HUD is facilitating a teleconference on Monday, August 5, 2014 to provide additional details. It was suggested that a MOU is developed for agencies in the High Desert to show a collaborative process to potential funders. Michele Bletcher will work on a list of funders and bring to the next meeting. She will contact Debbie Cannon and Vicki Nagel from the Academy of Grassroots Organizations for more information.
