In September 2007, the San Bernardino County Homeless Partnership (SBCHP) was formed to provide a more focused approach to our goal of ending homelessness within the County. The Partnership consists of city governments, community based organizations, faith-based organizations, educational institutes, non-profit organizations, private industry, and federal, state, and local government.

SBCHP was developed to promote a strong collaboration between agencies to direct the planning, development, and implementation of the County's 10-year-plan to end chronic homelessness. The Partnership meets on the third Wednesday of each month at the Behavioral Health Resource Center in Rialto. The Partnership facilitates better communication, planning, coordination, and cooperation among all entities that provide services and/or resources for the relief of homelessness in San Bernardino County.

Mission Statement

The Mission of the San Bernardino County Homeless Partnership is to provide a system of care that is inclusive, well planned, coordinated and evaluated and is accessible to all who are homeless and those at-risk of becoming homeless.

Interagency Council on Homelessness (ICH)	Don Smith	 The San Bernardino County Sheriff's Department in collaboration with the San Bernardino County Homeless Partnership, Loma Linda University and the Inland Empire Health Plan would like to invite you to "Proven Practices – Taking it to the Next Level" Conference to be held on Monday, March 23, 2015 from 9:00 am – 5:00 pm located at Loma Linda University, Centennial Complex, 24760 Stewart Street, Loma Linda, CA 93254. This conference will bring leaders from successful programs from around the nation to the Inland Empire and will help local service providers learn methods that are proven to reduce homelessness. Workshops will focus on research, policy practice, and resources will benefit local programs. This conference will provide the opportunity to network and collaborate on the forefront in San Bernardino County. They discussed open enrollment for housing choice vouchers, which closed Monday, March 9, 2015. They are also accepting applications for two Project-Based sites; Arrowhead Commons in San Bernardino which consists of one bedroom units on a first come, first serve basis. Meadowbrook Towers specifically houses seniors age 62 and older. 		
	Brenda Dowdy Andre Bossieux	The Homeless Youth Survey is Wednesday, April 8, 2015. Andre and Brenda serve on the Ad Hoc Youth Task Force with Supervisor Ramos as Chair. At the last meeting, Supervisor Ramos designated Brenda as the Co-chair. The targeted population will include unaccompanied, run-away homeless youth. They will be asked a series of questions by other Transitional Age Youth (TAY) and will be provided with a "goodie bag" to thank them for taking the survey. We are asking for volunteers to conduct the survey such as TAY youth and a student group from Loma Linda University Medical Center. We will be conducting surveys in Victorville, the Morongo Basin area, Yucca Valley, Redlands, San Bernardino, and Rancho Cucamonga. Lucy has identified about 100 kids who are unaccompanied. Wayne Hamilton, Homeless liaison for Morongo Basin, also knows of a group of youth to be surveyed. We have a Redlands liaison and in Rancho Cucamonga we have Operation New Hope. We are working with the City of Victorville to obtain a representative for that region. We also have two ministries including their youth department to assist as well. On Thursday, March 19, 2015 at 1:00 pm the Office of Homeless Services (OHS) will host a "train the trainers" class for all youth leaders. The Homeless Youth Task Force (HYTF) is collecting items for "goodie bags".

Don Smith	OHS is organizing a Coordinated Entry System pilot project, slated to begin in the spring of 2015 in targeted communities.
Brenda Dowdy	• The Needles Project Connect was held on Thursday, March 5, 2015 at the El Garces Train Depot. About 200 individuals and families attended; comments from local vendors as well as community members were positive and stated this was an event that has been needed for a long time, due to the lack of services in the area. It was a learning experience for some of the vendors, who were unaware of available services that could benefit their clients. Many clients and vendors expressed an interest in making this an annual event.
Don Smith	• There is an interest in engaging cities in our partnership more effectively. We would like to see city representatives come to the HPN meetings. If you have city contacts that may be interested in coming to these meetings, please encourage them to attend. There was also talk about engaging private market landlords more effectively, including creating a system where we can have a tenant education process which would result in some kind of certification that comes through our partnership. This would then be used in the housing search process for landlords.
Brenda Dowdy	Brenda suggested the need to connect on various levels and issues of housing to ensure we don't have competing efforts.
Don Smith	 There will be an ICH Housing Committee meeting on Wednesday, March 11th to be held at the office of Time for Change Foundation, 1255 E. Highland Avenue, Ste. 211, San Bernardino, CA 92404 beginning at 2:00 pm. Don met with Roberto Gonzalez, Housing Opportunities Collaborative Program Coordinator. They have a Virtual Counselor Network and are interested in what we do with Pathway to Housing and how the Housing Opportunities Collaborative can be a vehicle for this. The Homeless Provider Network had a great meeting in February 2015. People from the Peer-Driven Room & Board Coalition attended with Kim Savage presenting on Housing for Individuals with Disabilities & Fair Housing. She is a national expert on Land Use and Zoning issues regarding Fair Housing and Civil Rights as it relates to housing. Ms. Savage will conduct a workshop Thursday, March 12, 2015 from 10:00 am -12:00 pm at Victor Valley Family Resource Center. Ms. Savage works with city governments as well as providers. Kim's main message was: "Anytime you have a shared housing situation, it needs to function like a family. Once you start looking like a boarding house that's where you get in a position where regulations can start to kick in". Jose Marquez presented on the Community Foundation and the grant opportunities that they offer. The Community Foundation accepts competitive grant proposals from nonprofit organizations serving Inland Southern California. The Foundation is committee reviews and makes recommendations to the Board of Director's, which approves grants. The four primary program areas are: Health and Human Services, Youth and Families, Arts and Culture and Civic and Public Benefit. The Foundation is committed to providing support to the nonprofit organizations/agencies in the region. One of the ways in which this is accomplished is by stewarding endowed funds. Opportunities and Options for Permanent Supportive Housing in San Bernardino County	Doug Fazekas	 Housing and Employment has been around since 1994. Doug was hired by the Federal Government to work with the County to create Housing for this particular special needs population. We created the county's first Shelter Plus Care (SPC) Program with the Housing Authority of the County of San Bernardino. Since then, we've created thirteen SPC programs. The Housing and Employment Program Provides qualified DBH consumer's permanent, supportive, subsidized housing and/or employment. The program is comprised of two separate functions to provide housing and employment services.

Opportunities and Options for Permanent Supportive Housing in San Bernardino County (cont.)	Doug Fazekas	 The Housing Goal is to provide permanent independent housing for homeless, chronic homeless, or at risk of homeless mentally ill or dual diagnosed DBH consumers. We review housing referrals and interview applicants, submit housing applications and make recommendations to the Housing Program maintains United States Department of Housing and Urban Development (HUD) requirements in the submission of Annual Performance Reports (APR's). We also assist clients in maintaining compliance and eligibility. We are in collaboration with agencies such as the City of Ontario, Mercy House, and Beacon Property Management. We maintain HUD requirements of uploading data into the Homeless Management Information System (HMIS). We have five SPC tenant based voucher programs which is Federal. They are: Cornerstone, Whispering Pines, Stepping Stones, New Horizons II, and Good Samaritan. These projects are our chronic homeless only type projects. We have three SPC Project Based Voucher Programs: Laurel Brook, Lantern Woods, and Gateway. Master Leasing is a Mental Health Services Act (MHSA) funded Emergency Shelter Program. It is designed for DBH Full Service Partnership (FSP) consumers who are at risk of homelessness. If qualified, the consumer can move into a Shelter Plus Care Program. Our MHSA Housing Programs are: Vintage at Kendall for seniors, Magnolia @ 9th for seniors, Mt. Breeze Villas for ages 18 and older, and Phoenix Apartments for ages 18-25. We have three MHSA Housing projects in the works. Horizons at Yucaipa for seniors, Siena Apartments for adults and small families, and Project Bloomington for adults. The goal of our Employment team is to help DBH consumers obtain and maintain employment. To assist housing DBH consumers secure qualifying income, and to provide direct services independently and in conjunction with the Department of Rehabilitation (DOR). The Employment staff co
Questions re: presentation	All Attendees	 With regards to Master Leasing, is DBH the lease holder? When people will find a marketplace they are interested in and come to housing, then we negotiate a lease arrangement through the landlord? Is it short-term? A: we arrange housing through the HACSB. It is a short term lease of up to six months. After those six months, if it doesn't work, do they just go back to the streets? A: We don't send them back to the streets. We work with the case managers and housing navigators for alternative resources in the community. Can you use MHSA funds to house people in room and boards? A: It's not the intent for Room and Board. Master Leasing was the bridge at looking at long-term housing. With regards to the Bloomington Project, will there be a percentage outside of the low income? A: Yes. It is an affordable Housing project for the community. How many MHSA units are at the Siena Project? A: We have 15. All are one-bedroom units and furnished. Can providers and individuals reach out to the Housing Navigators and get connected with housing options? A: They have to go be a DBH consumer receiving services to access housing through Housing & Employment.

Pathways to Housing	Don Smith	 Today we focus on housing access points in the West Valley Region for people dealing with behavioral health issues and options available to them. The goal is to identify agencies or providers who have access to various housing options. What options are there for those who are chronically homeless or dealing with Mental Health and/or Substance abuse issues or behavioral health challenges? What types of housing options are there? Whether it's emergency, bridge or permanent supportive housing? Some resources identified were: DBH – Selma Saldamando is the housing referral contact for the West End region Foothill AIDS Project - they have housing vouchers for people living with HIV or AIDs. Cedar House - residential substance abuse. Frazee Community Center - sober living transitional housing (in San Bernardino). Inland Valley Recovery Services (IVRS) – residential treatment and transitional housing. Peer Driven Room and Board Coalition – we need to identify more West End providers.
