In September 2007, the San Bernardino County Homeless Partnership (SBCHP) was formed to provide a more focused approach to our goal of ending homelessness within the County. The Partnership consists of city governments, community based organizations, faith-based organizations, educational institutes, non-profit organizations, private industry, and federal, state, and local government.

SBCHP was developed to promote a strong collaboration between agencies to direct the planning, development, and implementation of the County's 10-year-plan to end chronic homelessness. The Partnership meets on the third Wednesday of each month at the Behavioral Health Resource Center in Rialto. The Partnership facilitates better communication, planning, coordination, and cooperation among all entities that provide services and/or resources for the relief of homelessness in San Bernardino County.

Mission Statement

The Mission of the San Bernardino County Homeless Partnership is to provide a system of care that is inclusive, well planned, coordinated and evaluated and is accessible to all who are homeless and those at-risk of becoming homeless.

We service a lot of areas but there is still a need for additional transportation in the Desert Mountain region. The VVTA is looking to help nonprofits with funding and van opportunities. They are collaborating with an insurance provider that can help with the insurance of the vans. There is new software that will be launched to help with the needs of the nonprofit that will be on a broker pay scale that is a discount to the nonprofits. Tablets will be available for agency's that collaborate in their program.
St. Joseph Health St. Mary	Kevin Mahany	<ul style="list-style-type: none"> The Victorville Project Homeless Connect is scheduled for Wednesday, June 3, 2015, from 10:00 am – 2:00 pm at the St. Joan of Arc Catholic Church and is geared toward to the chronically homeless in the community. The location will hold about 25 vendors. Lunch will be provided by the Department of Behavioral Health (DBH) Office of Homeless Services (OHS). Our goal is to have vendors at the fair who can house chronically ill and homeless people. The Sheriff's Department HOPE Team will help get the word out as well as look for resources for event. Michele Bletcher and/or Deanna Luttrell will be working on this project. Supporters include Knowledge and Education for Your Success (K.E.Y.S.), DBH, Aaron Moore, Kevin Mahany, High Desert Homeless Shelter, Molding Hearts, Victor Valley Family Resource Center and other non-profits in the Desert Mountain Region.
