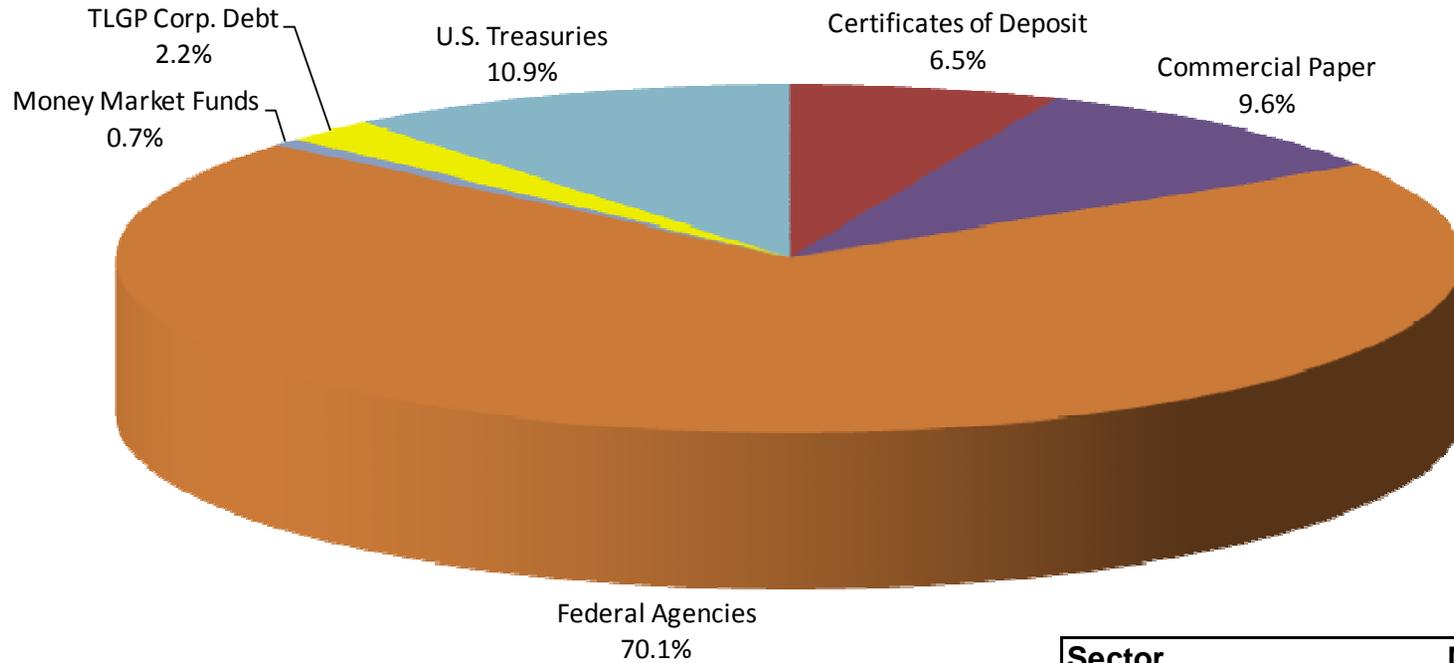

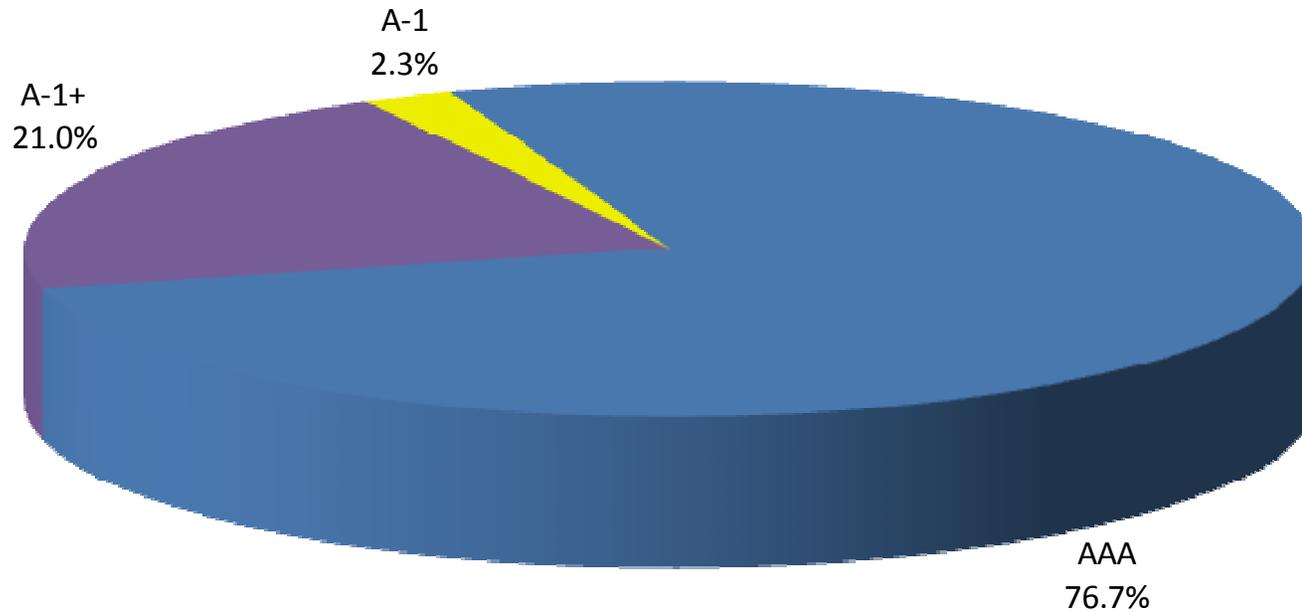

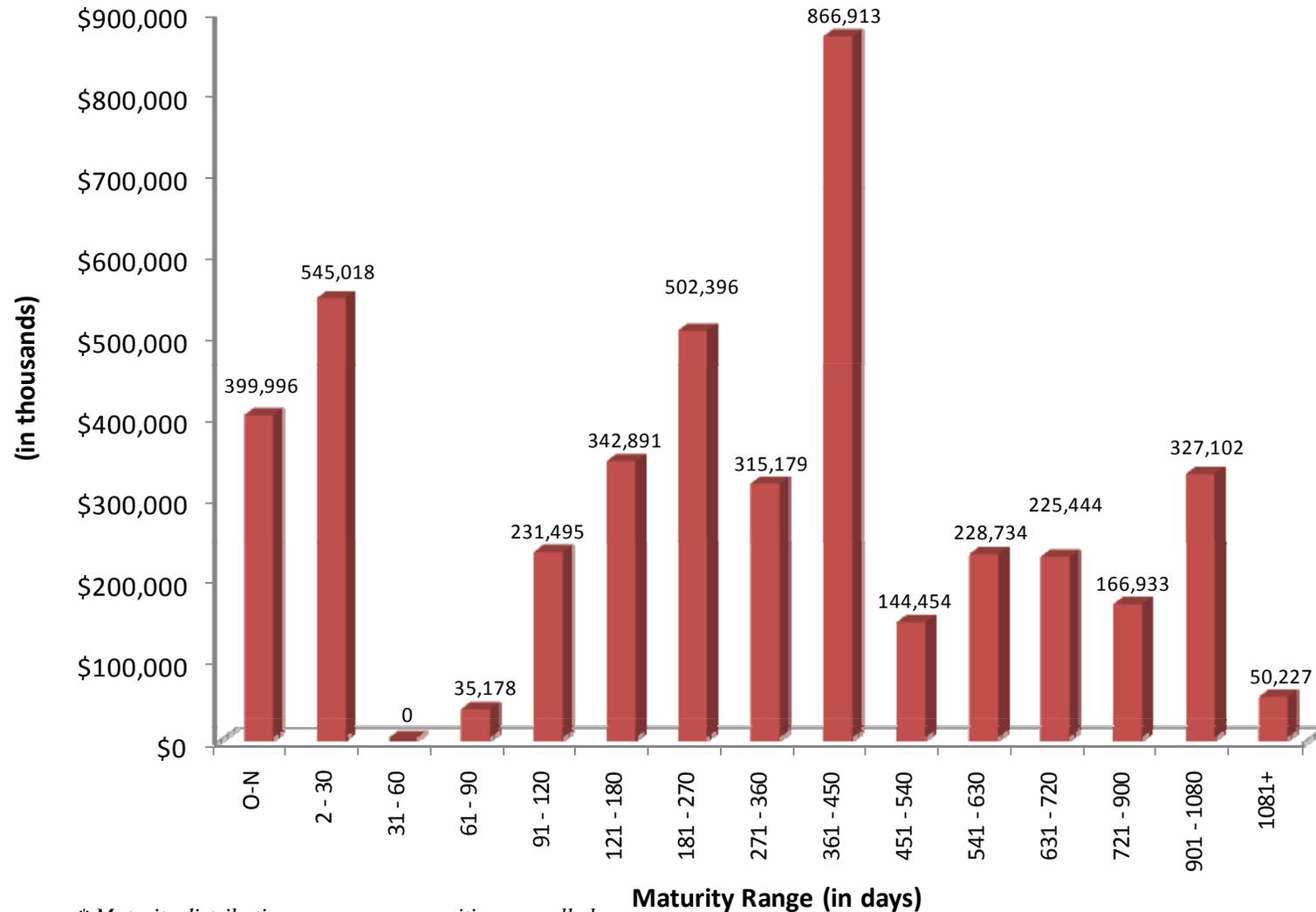
# San Bernardino County Pool Credit Quality Distribution (as of 2/28/10)
