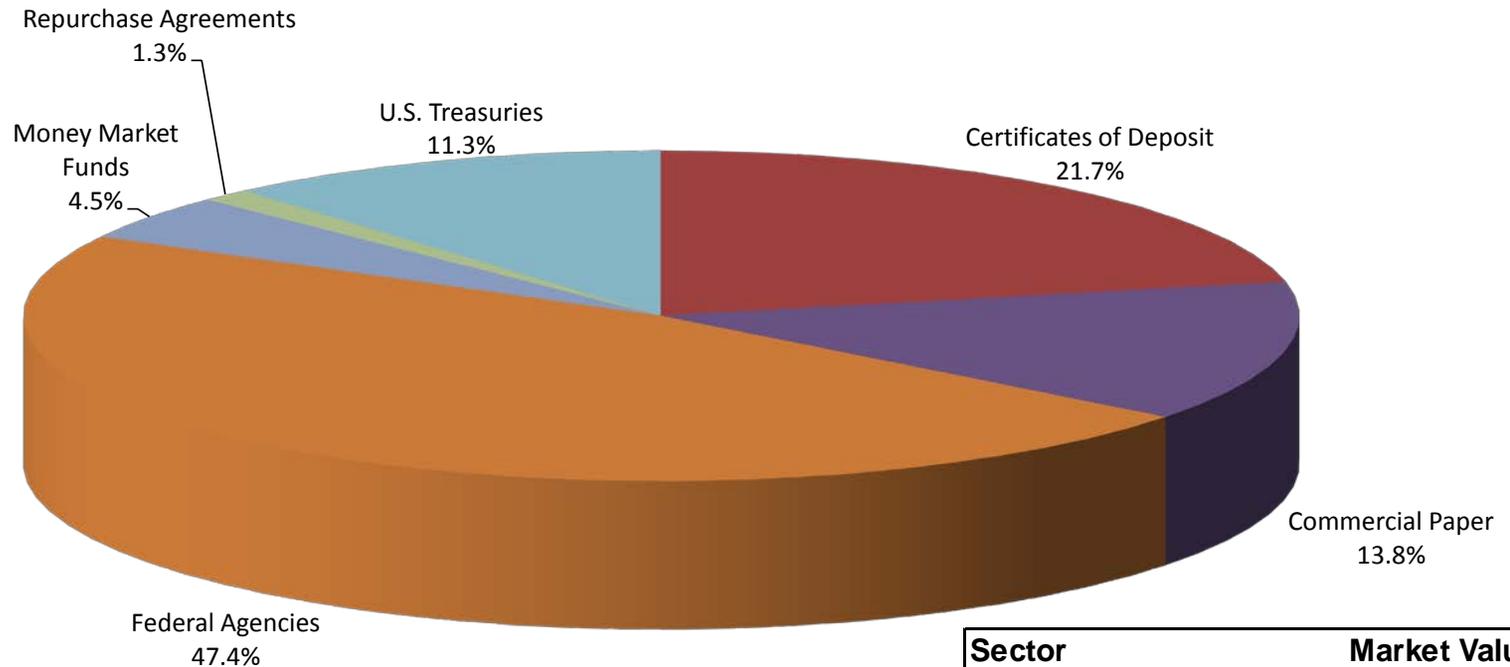

## Sector Distribution (as of 8/31/2012)



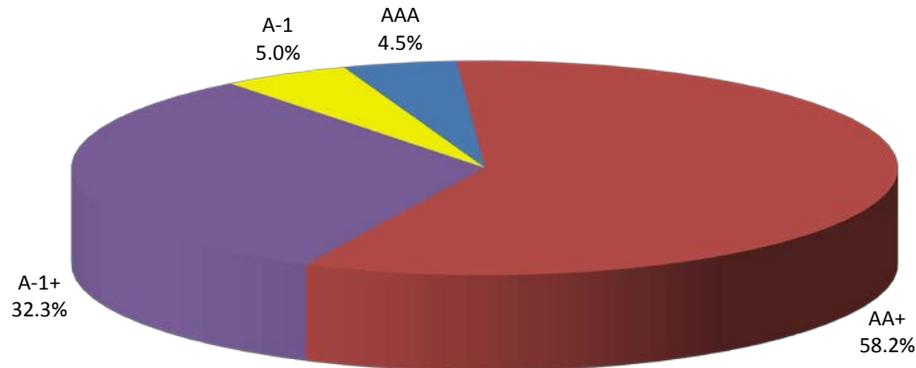

## Credit Quality Distribution (as of 8/31/2012)

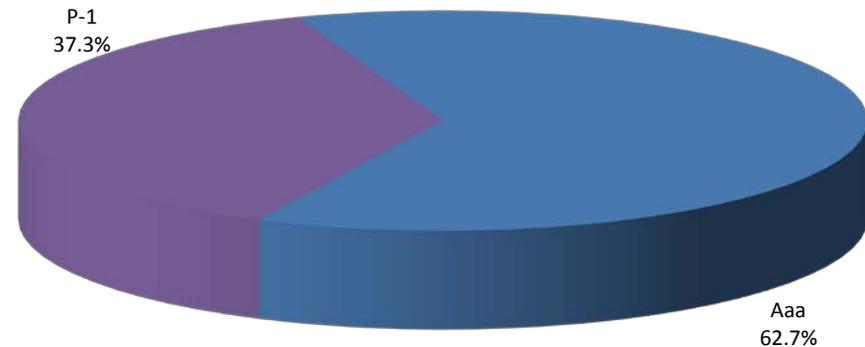

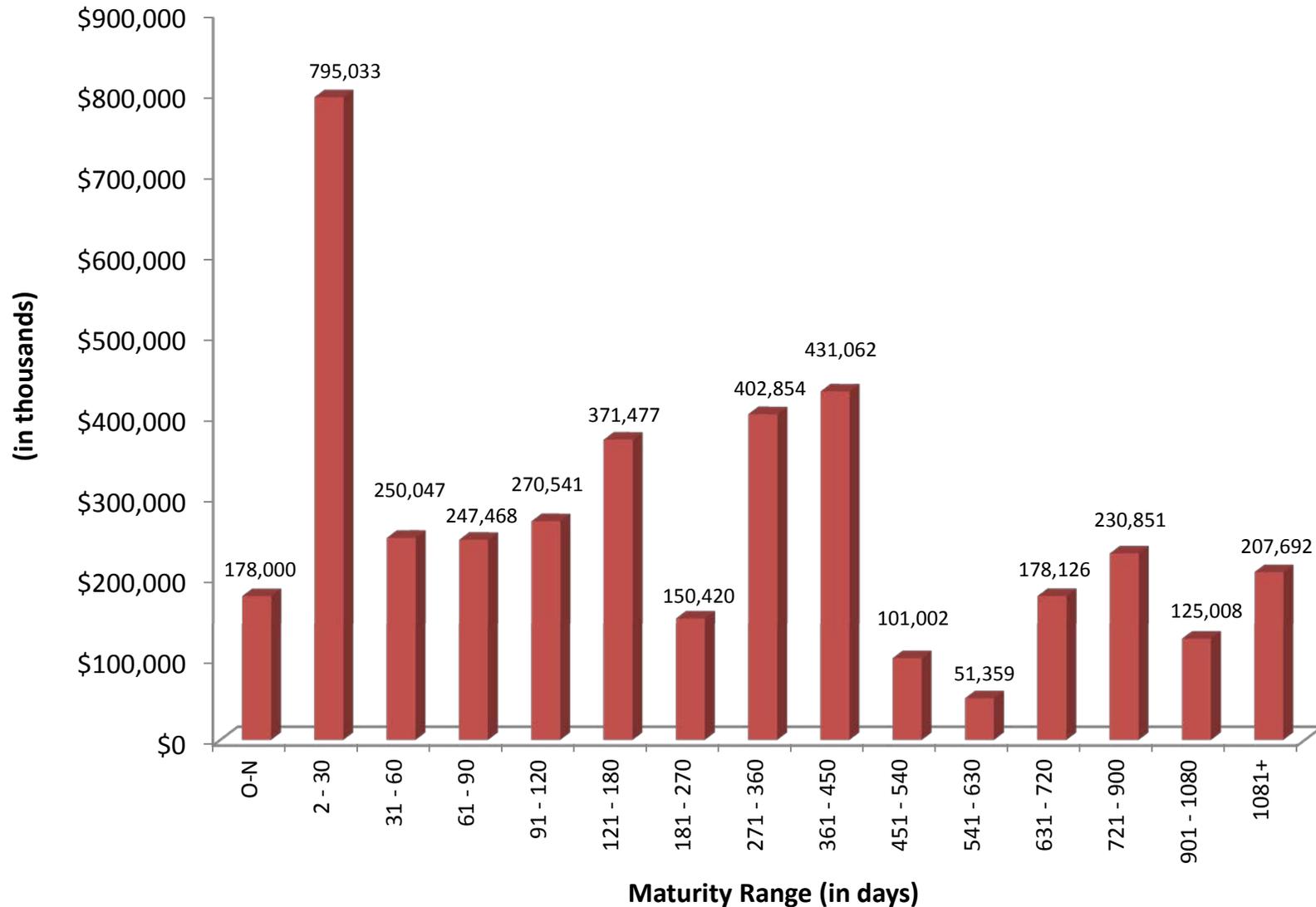
