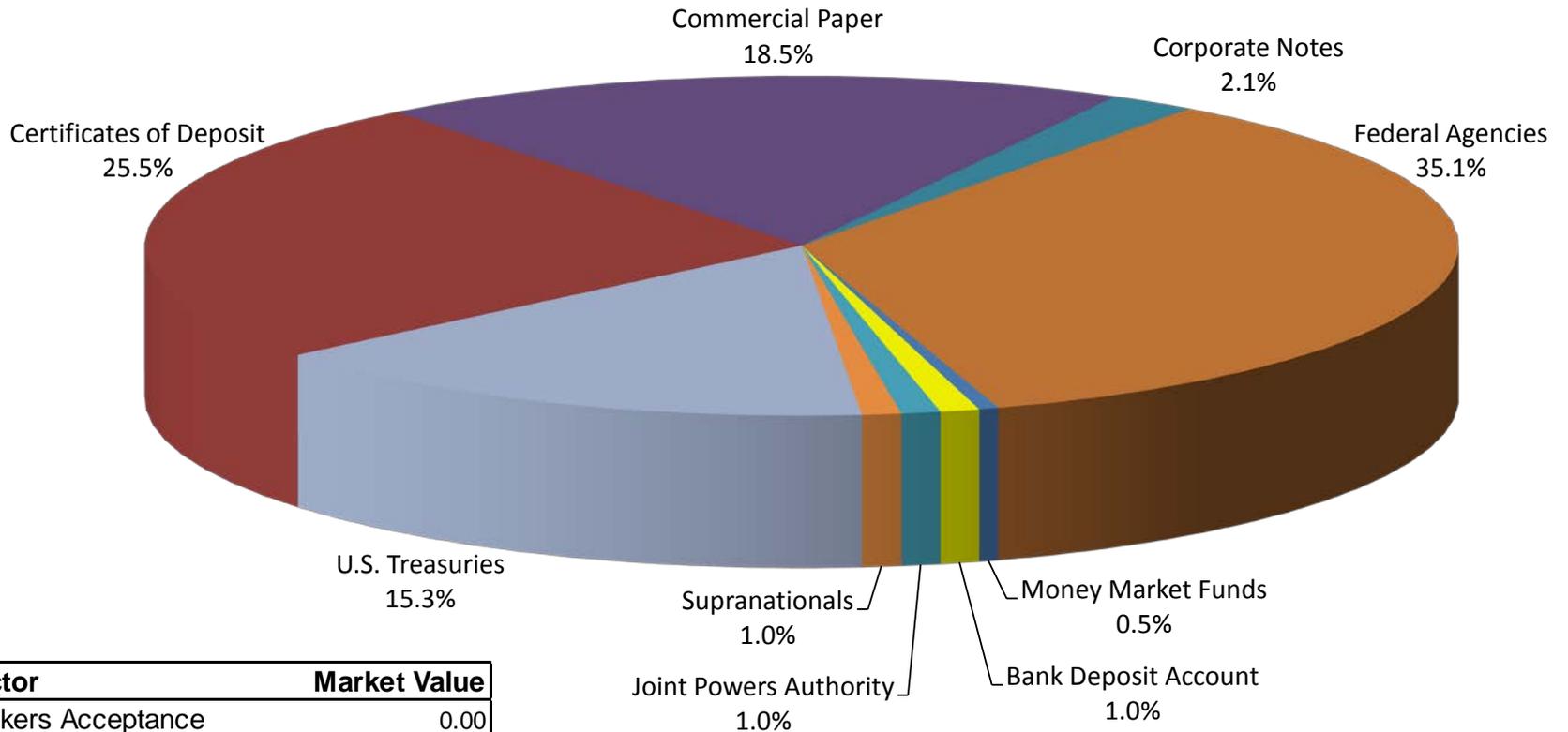

San Bernardino County Pool Sector Distribution (as of 4/30/2015)

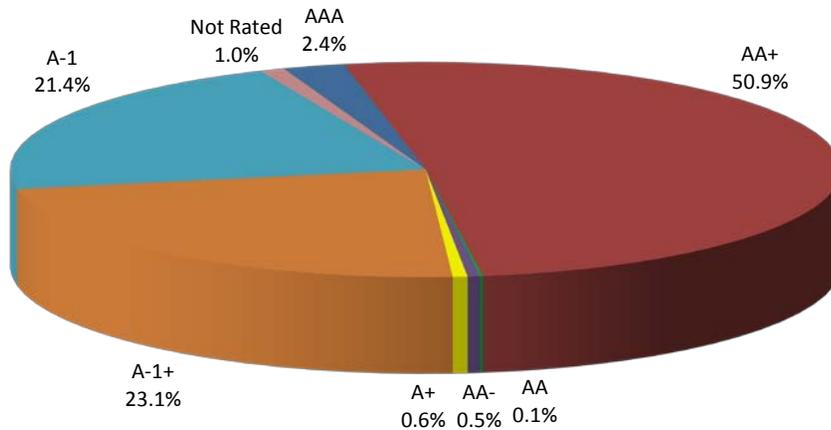

San Bernardino County Pool Credit Quality Distribution (as of 4/30/2015)

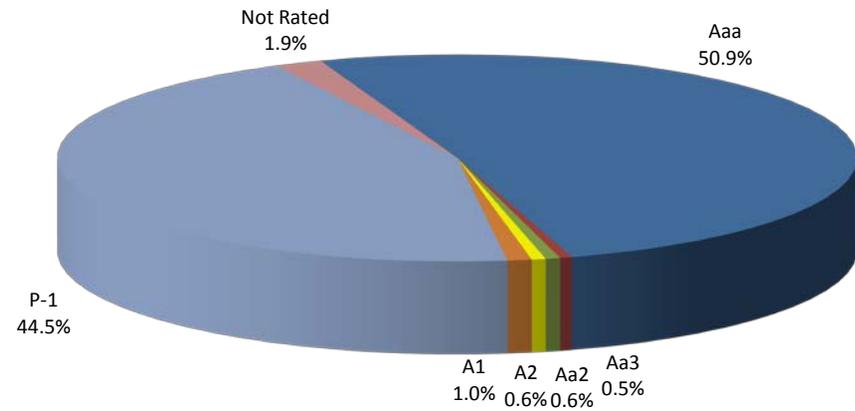

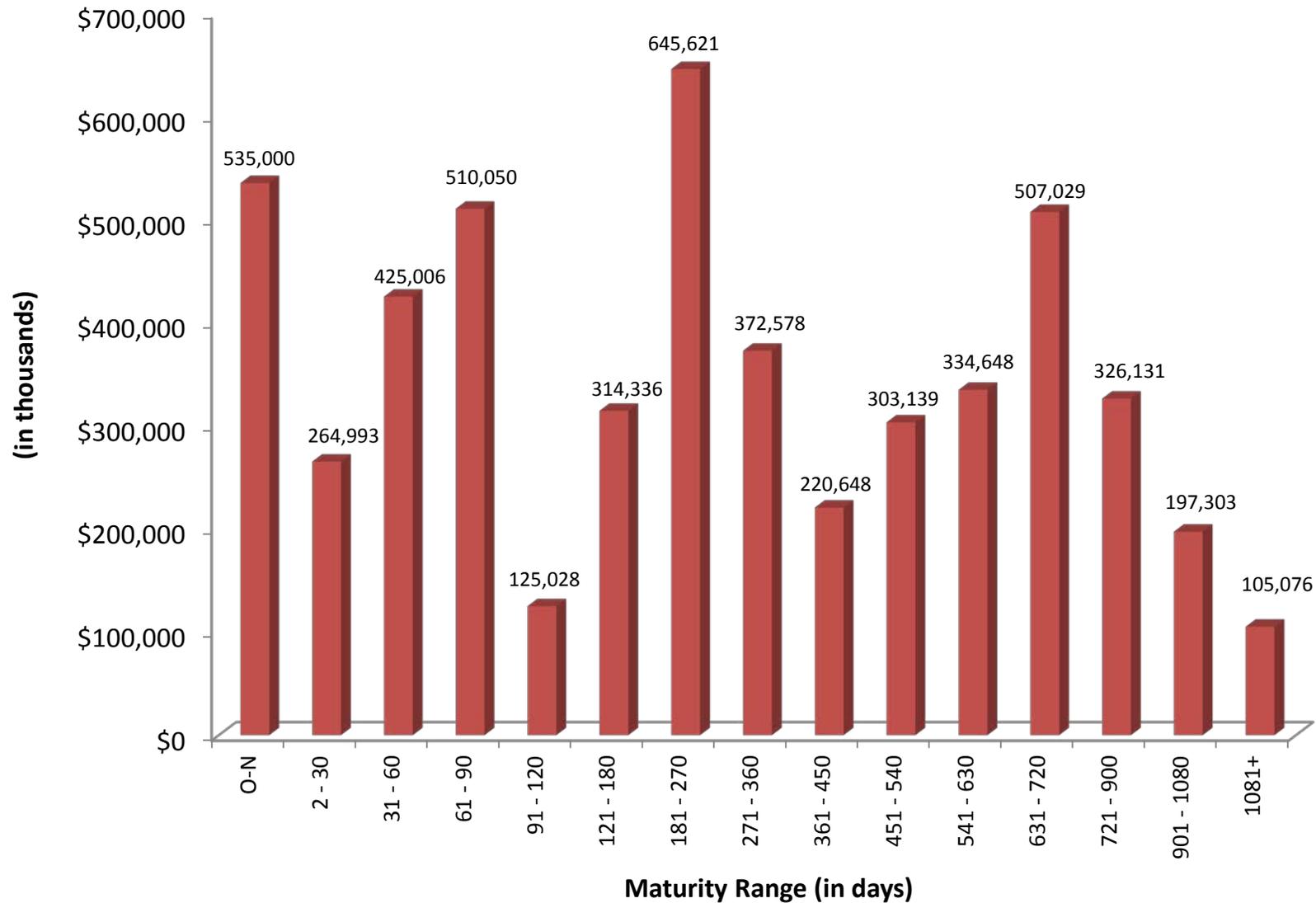
