As a property owner, tenant, or person who has requested notice, please be advised that the County of San Bernardino Solid Waste Local Enforcement Agency (LEA) received, and is considering an application to modify the solid waste facility permit (SWFP) for the Victorville Sanitary Landfill. The LEA is certified by the California Integrated Waste Management Board to enforce state laws and regulations at solid waste sites within the County of San Bernardino, including all active and closed landfills.

Description of Project and LEA's Preliminary Determination

The Victorville Sanitary Landfill is located at 18600 Stoddard Wells Road, Victorville, CA 92392.

On October 1, 2009 the LEA accepted for review, the permit application package for Victorville Sanitary Landfill requesting to change the self monitoring reporting period from 15 to 30 days and to amend language in the JTD to reflect the acceptance of treated wood waste, which has been approved by the Lahontan Regional Water Quality Control Board. No other changes to the SWFP are under consideration at this time.

The LEA finds that the proposed change is a non-material change pursuant to Title 27 §21665 and qualifies as a permit modification. The LEA's preliminary determination is that the proposed permit modification be approved.

The decision to approve or deny the SWFP modification will be made by the LEA within 120 days of the date the application was deemed complete as required by State statute, and will be submitted to the California Integrated Waste Management Board (CIWMB) for concurrence.
