POINTS 2	Compliance date not specified	Inspector Comments: Observed employees washing wiping cloths on the food preparation sink/ hand sink, making the hand sink unaccessible for proper hand washing. Discontinue this practice. Only use the hand sink to wash hands and the food preparation sink to prepare food.

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

7. PROPER HOT AND COLD HOLDING TEMPERATURES

POINTS 2	Compliance date not specified	Inspector Comments: 1) Observed a container of tofu stored in the front two door reach-in refrigerator measured at 50F. The owner stated the tofu had been stored for less than one hour. Ensure potentially hazardous foods are held at 41F or below or 135F and above. 2) One container of dumplings was measured at 47.3F in the rear kitchen two door reach-in refrigerator. The owner stated the dumplings had been stored in the reach-in refrigerator for less than two hours. Ensure potentially hazardous foods are held at 41F or 135F and above.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

Provide time stamps at the food product that is to be served or removed within four (4) hours of placing the food product at room temperature. Note-The manager provided time stamps to the food products.

Violation Description: When time only, rather than time and temperature, is used as a public health control; food must be marked or otherwise identified as to what time the food was removed from temperature control. (114000) Food items shall not exceed the time marked. (114000)

Ensure to place any open food products in a container with a lid. Ensure to label food product.

Violation Description: Any food is misbranded if its labeling is false or misleading, if it is offered for sale under the name of another food, or if it is an imitation of another food for which a definition and standard of identity has been established by regulation. (114087, 114089, 114089.1(a, b), 114090, 114093.1) Bulk food available for consumer self-service must have an information label, sign, and/or other method of notification that includes the label information. (114089) Prepackaged food must bear a label that complies with the labeling requirements as prescribed by the Sherman Food, Drug and Cosmetic Law. (114089 and 114089(a)) Restaurants must provide a brochure placed at the point of sale that includes at least calories, sodium, saturated fat, and carbohydrates information per menu item. For sit-down restaurants, the information must be provided at the table. Drive-thrus are required to have the brochures available upon request and have a notice of the availability at the point of sale. (114094)

Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. Ensure to store personal items away from food/ food storage areas.

Violation Description: The premises of each food facility shall be kept clean and free of litter and rubbish; all clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces; the facility shall be kept vermin proof. (114067 (j), 114123, 114143 (a) & (b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282) Food preparation sinks, handwashing sinks and warewashing equipment shall not be used for the cleaning of maintenance tools, the holding of maintenance materials, or the disposal of liquid wastes. (114123) Open-air barbecue and/or outdoor wood burning oven must operate on the same premises, in conjunction with a permanent food facility and not in an area that may pose as a fire hazard. - A permit suspension (closure) on your last graded inspection.
