After asking how they are washing their hands, employee went on to state they wash their hands in cold water only. The owner of the facility arrived shortly after and made adjustments to make the hot water turn back on. The employees were not knowledgeable about these adjustments they believed that the hot water did not work and therefore were washing hands inadequately. Owner stated that the water is turned off because of a leak. Hot water was observed above 110F at this sink.</p> <p>Discontinue this practice. Hot and cold water shall be available for proper handwashing. Despite faucet leak employees shall be equipped with hot water. Repair this item immediately.</p> <p>Corrected on site.</p>

Employees are not to wrap or package leftover food using bare hands or unclean utensils. Hand sanitizers may be used after proper hand washing.
