Complainant found worms in salmon.

FINDINGS:

After a complete and thorough inspection of the kitchen and rear janitorial facilities no evidence was observed of the presence of worms in salmon. All salmon was observed in good condition. Salmon was measured at 41 F in cold holding units and at 140 F at buffet line.
