Ensure all food contact surfaces are sanitized in sanitizing solution after they are washed with soap and rinsed: a minimum of 200 ppm for quaternary ammonium solution for at least one minute or a minimum of 100 ppm for chlorine sanitizer solution for at least 30 seconds.

Water temperature was measured at 120 F. When the operator was questioned, he stated the PHFs are being defrosted. The operator stated the bottles get defrosted approximately for an hour inside hot water. Ensure one of the following approved thawing methods is utilized: 1) Under refrigeration that maintains the food temperature at 41F or below. 2) Completely submerged under cold running water (less than 70F) of sufficient velocity to flush loose particles for less than 2 hours. 3) In a microwave oven if immediately followed by immediate preparation. 4) As part of a cooking process. Corrected on site. The operator placed the bottles of frozen yogurt under cold running water.

- Four (4) or more critical violations (codes 1-23) noted during an inspection, or
- A permit suspension (closure) on your last graded inspection.
