Per complainant rats were observed on shelves and running down aisles.

Reference - HSC

Per operator:

Per manager they have had rodent sightings in the pet food aisle. Per manager they have also had sightings in aisle 7, 6, and in the bakery.

Observations:

- Fresh rodent droppings in several sections of the pet food aisle.
- Cat food bag with chew marks open with rodent droppings present.
- Bird seed bags with chew marks open with rodent droppings present.
- Fresh droppings behind dog and cat food bags on shelves.
- Fresh droppings along the ground under the pet food aisle shelves.

The following was observed on aisle 7 (baked goods):

- Splenda boxes with chew marks.
- Splenda box open along with open packets.
- Marshmallows with chew marks.
- Spilled sugar on shelf with rodent droppings.
- Open packet of shredded coconut.

Facility closed on this day, due to rodent infestation.

- Take steps to eliminate vermin from the facility.
- Seal all potential points of entry preventing vermin from entering the facility.

Violation Description: If an imminent health hazard is found, an enforcement officer may temporarily suspend the permit and order the food facility immediately closed. (114409, 114405)
