- a pest control invoice dated 06/06/19 which stated that the technician provided a treatment for german cockroach and there will be a 2 week follow up service
- observed there to be no cockroaches inside the facility during the inspection
- observed the exterior doors to be sealed, specifically at the bottom
- observed multiple cove base tiles to be re-sealed
- employee stated all affected areas were thoroughly cleaned and sanitized
- facility, equipment, and utensils appeared to be clean
