*Violation Description:* All Body Art artists shall registered with the Division of Environmental Health Services.

Not In Compliance

*Inspector Comments:* Observed five body art practitioners (Richard Pineda, Wayne Gauthier, Adam Echeverria, Dillon Smith, and Matt Dyson.) registered with the Division of Environmental Health Services. These three practitioners were registered over a year prior to Safe Body Art Act (AB 300). All body art artists shall be in compliance with AB 300.

**Overall Inspection Comments**

This facility is scheduled for a re-inspection on or after 10-10-12 to verify that the body art practitioners practicing at this facility are in compliance with AB 300. In addition, this facility shall have the decontamination and procedure areas in compliance with AB 300, and the Infection Prevention and Control Plan (IPCP) available by 10-10-12. Observed decontamination and procedure areas not having a hand washing sink, and the facility not having an IPCP available. Failure to comply with request, legal action will be taken. Information about AB 300 provided to body art facility owner, Jennifer Cooper, on this date.
