Observations

Tier 1 Violations

1. Permit - Registration

Comply by 10/8/2012

Violation Description: All Body Art artists shall registered with the Division of Environmental Health Services.

Not In Compliance

Inspector Comments: Observed three (3) body art practitioners (Christopher Gaylord, Sean White, and Richard Adams) working at this facility without being registered with the county. In addition, one body art artist was observed having a registration, but it was obtained in 2005. The three unregistered practitioners are prohibited by law to provide body art services in San Bernardino County. All body art artists shall be in compliance with AB 300 before providing services in San Bernardino County.

Violation Reference: HSC

Overall Inspection Comments

This facility is scheduled for a re-inspection on or after 10-19-12 due to the following violations:

-Lack of hand washing sink in the procedure area. A hand washing sink in compliance with AB 300 shall be provided to this area.

-Lack of Infection Prevention and Control Plan (no IPCP available)

-Certificate of registration not in compliance with AB 300

Failure to correct violations on or before 10-19-12 will result in legal action taken. Information about AB 300 provided to owner, Val Matteson.
