Tier 1 Violations

1. Contact Surfaces - Spore Testing

Comply by 10/12/2012

Violation Description: All sterilizer shall be spore tested at least monthly to assure that all spores have been destroyed.

Not In Compliance

Violation Reference: HSC

Inspector Comments: No spore test results observed. All sterilizer shall be spore tested at least monthly to assure that all spores have been destroyed.

2. Disposal - Sharps

Comply by 10/12/2012

Violation Description: Sharps shall be placed in an approved sharps container and disposed of by an approved method.

Not In Compliance

Violation Reference: HSC - 117600

Inspector Comments: No approved method for disposal of sharps containers observed. Obtain a contract with a certified medical waste hauler or mail-back company.

3. Employees - Eat, Drink or Smoking

Comply by 10/12/2012

Violation Description: The Body Art artists shall not smoke, eat or drink at the workstation or cleaning room.

Not In Compliance

Violation Reference: HSC

Inspector Comments: Observed body art artist smoking and drinking in the sterilizing room. The Body Art artists shall not smoke, eat or drink at the workstation or cleaning room.

4. General Protection - Autoclave Bags

Comply by 10/12/2012

Violation Description: After cleaning, non disposable instruments shall be packaged into autoclave bags with color change indicators or properly stored for vender pickup and sterilization.

Not In Compliance

Violation Reference: HSC

Inspector Comments: Observed used non-disposable instruments left on the counter of work station. Work stations shall be cleaned and disinfected after each procedure.

5. Identification - Consent Form

Comply by 10/12/2012

Violation Description: Provide and maintain a consent form with picture identification card.

Not In Compliance

Violation Reference: HSC

Inspector Comments: No all information required by AB 300 was observed on the consent form. The consent form shall be in compliance with AB 300.

6. Permit - Registration

Comply by 10/12/2012

Violation Description: All Body Art artists shall registered with the Division of Environmental Health Services.

Not In Compliance

Violation Reference: HSC

Inspector Comments: Observed body art practitioner Shadow Steele (Stephen E. Steele) being registered with San Bernardino County. However, he obtained his registration on 11-09-05. All body art artists providing service in san Bernardino County shall be in compliance with AB 300.
