	Not In Compliance	<i>Inspector Comments:</i> Observed various food items holding at temperatures of 45F - 51F. All items moved to walk in cooler. All items were prepared this morning. Repair and maintain unit to hold all cold holding food items at 41F or below.

	Not In Compliance	<i>Inspector Comments:</i> Observed no label on bulk container of dry chicken batter. Maintain proper labeling.

34: Warewashing facilities: installed, maintained, use

POINTS 1	Compliance date not specified	<i>Violation Description:</i> Food facilities that prepare food shall be equipped with warewashing facilities. Testing equipment and materials shall be provided to measure the applicable sanitization method. (114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125) A thermometer must be readily available to monitor the temperature of the water at the warewashing sink. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.
	Not In Compliance	<i>Inspector Comments:</i> Observed chlorine level at 0ppm in kitchen area. Maintain chlorine sanitizer between 100 - 200ppm. Observed no data plate on dishwasher. Provide data plate for minimum specifications for machine.

35: Equipment/Utensils - approved; installed; clean; g

POINTS 1	Compliance date not specified	<i>Violation Description:</i> All utensils and equipment shall be fully operative and in good repair. (114175). All utensils and equipment shall be approved, installed properly, and meet applicable standards. 	Not In Compliance	<i>Inspector Comments:</i> Observed debris on gaskets to reach in coolers. Clean and maintain on a routine basis.

40: Wiping cloths: properly used and stored

POINTS 1	Compliance date not specified	<i>Violation Description:</i> Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)
	Not In Compliance	<i>Inspector Comments:</i> Observed wiping cloths under 3 cutting boards. Maintain use of slip resistant mat.

41: Plumbing; proper backflow devices

POINTS 1	Compliance date not specified	<i>Violation Description:</i> The potable water supply shall be protected with a backflow or back siphonage protection device, as required by applicable plumbing codes. (114192) All plumbing and plumbing fixtures shall be installed in compliance with local plumbing ordinances, shall be maintained so as to prevent any contamination, and shall be kept clean, fully operative, and in good repair. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. (114171, 114189.1, 114190, 114193, 114193.1, 114199, 114201, 114269)
	Not In Compliance	<i>Inspector Comments:</i> Observed less than one inch air gap at floor sink. Provide and maintain at least a one inch air gap for all pipes draining into floor sink.
