Based on an inspection this day, the items marked below identify the violation(s) in operation or facilities which must be corrected. The Permittee has the right to a hearing if requested in writing within 15 calendar days of receipt of this notice, to show cause why the permit to operate should not be suspended. Failure to correct listed violation(s) prior to the designated compliance date may necessitate an additional reinspection at a charge of \$61.25 per 15 minutes with a minimum time of 30 minutes, and a minimum charge of \$122.50

Observations

Tier 1 Violations

1. Contact Surfaces - Spore Testing

Comply by 10/22/2012

Violation Description: All sterilizer shall be spore tested at least monthly to assure that all spores have been destroyed.

Not In Compliance

Violation Reference: HSC

Inspector Comments: No spore test results observed. All sterilizer shall be spore tested at least monthly to assure that all spores have been destroyed. This facility has a broken sterilizer at this time, but sufficient sterilized equipment for the next four days. Provide repairs to sterilizer or use only single-use pre-sterilized equipment.

2. Permit - Registration

Comply by 10/22/2012

Violation Description: All Body Art artists shall registered with the Division of Environmental Health Services.

Not In Compliance

Violation Reference: HSC

Inspector Comments: Observed two body art practitioners (Gavino Hernandez and Daniel Westbrook) providing service at this facility without being registered with San Bernardino County Environmental Health Services and one (Cesar Lopez) registered in 2008. Gavino Hernandez and Daniel Westbrook are prohibited from providing services as body art artists without being registered in this County. Cesar Lopez shall obtain, within two weeks, a new registration in compliance with AB 300.

Overall Inspection Comments

This facility is scheduled for a re-inspection on or after 11-02-12 due to the following violations:

- Lack of Infection Prevention and Control Plan
- Lack of hand washing sink in the procedure area
- Lack of soap and paper towel dispensers in decontamination room
- Decontamination room walls and ceiling not in compliance with AB 300
- Lack of body art certificate of registration under AB 300 for Cesar Lopez
- Consent form not in compliance with AB 300
- Broken sterilizer and sterilized multi-use equipment not properly labeled
- Direct access between the body art facility and the residential dwelling

Failure to correct violations on or before 11-02-12 will result in legal action taken.
