POINTS 1	Compliance date not specified	<i>Violation Description:</i> Food shall be thawed under refrigeration; completely submerged under cold running water (less than 70F) of sufficient velocity to flush loose particles for less than 2 hours; in microwave oven; or during the cooking process. (114018, 114020, 114020.1) <i>Inspector Comments:</i> Observed some frozen packaged cooked breaded chicken and gravy stored in boxes on kitchen food prep table awaiting food preparation, discontinue partially thawing potentially hazardous foods out of refrigeration. Slacking of potentially hazardous frozen food is no longer allowed in Cal Code.
