Violation Description: During your last routine inspection, it was noted that your facility was in violation of the food worker certification requirement for San Bernardino County. Since the inspection, food worker certification compliance has not been verified by Environmental Health staff. A billable reinspection has been conducted on this date to verify compliance.

Inspector Comments:

- A billable reinspection was conducted at facility regarding food handler cards (6) that has not been received by Department of Environmental Health Services (DEHS) after 14 days, from last routine inspection conducted on 10/09/12.
- Upon inspection, operator stated that there is 1 more food handler card missing for 1 employee. Ensure employee obtain food handler card and fax complete food handler card sheet to San Bernardino office.
- Facility has 7 days to send to food handler cards. Non-compliance will result in further charged inspections.
