Critical Violations

9: Proper cooling methods

POINTS Compliance date not specified
4 Complied on 1/31/2013

Violation Description: All potentially hazardous food shall be RAPIDLY cooled from 135F to 70F, within 2 hours, and then from 70F to 41 F, within 4 hours. Cooling shall be by one or more of the following methods: in shallow containers; separating food into smaller portions; adding ice as an ingredient; using an ice bath; stirring frequently; using rapid cooling equipment; or, using containers that facilitate heat transfer.

PHF is to be cooled within 4 hours to 41F if prepared from ingredients at ambient temperature. Deliveries of PHF is to be cooled to below 41F within 4 hours if received between 41F to 45F.

Inspector Comments: Observed 2 5 gallon containers of beef soup in walkin at 53F. This food was made last night. It has been in the danger zone too long. Potentially hazardous food must be quickly cooled from 135F to 70F in 2 hours, 70F to 41F. in 4 hours by using long 2 inch stainless steel pans, ice paddles, ice baths, etc. Obtain the proper supplies. Train employees.

This food was discarded.

Non-critical Violations

4: Proper eating, tasting, drinking or tobacco use

POINTS Compliance date not specified
2 Not In Compliance

Violation Description: Employees shall not eat, drink, or use tobacco in non-designated areas where contamination may result. (113977) An employee shall not use a utensil to taste food more than once without being properly washed, rinsed and sanitized between uses. (113976)

Inspector Comments: Observed employee in kitchen eat the food that was in the breakfast bar. No eating, drinking or smoking is allowed in these areas.

7: Proper hot and cold holding temperatures

POINTS Compliance date not specified

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

Inspector Comments: Observed sliced ham that was in an ice bath at 57F. Potentially hazardous food must be kept at or below 41F. This food was discarded. Maintain good ice baths around these foods. Thi2 food was discarded.

Observed food temperature of 45F in the front cashier area. Repair refrigerator.

14: Food contact surfaces: clean and sanitized

Violation Description: All food contact surfaces of utensils and equipment shall be clean and sanitized. (113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101 (b-d), 114105, 114109, 114111, 114113, 114115 (a, b, d), 114117, 114125(b), 114135, 114141)

Inspector Comments: Observed that employee was running dishes thru the dishwasher when the booster heater was not operating and the hot water temperature of the water was up to 180F. Train, educate employees.

23: No rodents, insects, birds, or animals

POINTS Compliance date not specified
2 Not In Compliance

Violation Description: Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. (114259.4, 114259.5)

Inspector Comments: Observed rodent droppings in storeroom. Immediately clean up droppings. Eliminate rodent infestation. Facility has monthly pest control service, On Call Termite & Pest Control Service. Observed receipts 1-28-13, 12-28-13, etc. Contact pest control company. Make sure the building is rodent proofed.

Violation Description: All food shall be separated and protected from contamination. (113984 (a, b, c, d, f), 113986, 114060, 114067(a, d, e, j), 114069(a, b), 114077, 114089.1 (c), 114143 (c)) All food shall be stored, prepared, displayed or held so that it is protected from contamination.

Inspector Comments: Observed raw meat stored in the same refrigerator drawer as cooked foods. Store raw meat in a separate drawer. Store cooked foods in another drawer to prevent cross contamination.

34: Warewashing facilities: installed, maintained, use

Violation Description: Food facilities that prepare food shall be equipped with warewashing facilities. Testing equipment and materials shall be provided to measure the applicable sanitization method. (114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125) A thermometer must be readily available to monitor the temperature of the water at the warewashing sink. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.

Inspector Comments: Obtain some chlorine sanitizer test strips for the bar area.
