Inspector Comments: Ensure employees know minimum cooking temperatures of hamburger (155 degrees) and minimum cooking temperature of eggs (145 degrees F). All employees must be clearly able to demonstrate cooking temperature knowledge (along with sanitizer bucket strengths, contact time, hot and cold holding temperatures, etc.)
