6: Adequate handwashing facilities supplied & accessible

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

Inspector Comments: Observed paper towel and soap missing at both hand washing sinks. Provide soap and paper towel at all hand washing sinks. Also observed ice cream scoop sitting inside of a hand washing sink. Use hand washing sink for intended purpose only.
