Violation Description: Employees are required to wash their hands: before beginning work; before handling food / equipment / utensils; as often as necessary, during food preparation, to remove soil and contamination; when switching from working with raw to ready to eat foods, after touching body parts; after using toilet room; or any time when contamination may occur. Gloves shall be worn if an employee has cuts, wounds, fake nails, nail polish, and/or rashes. Gloves are to be used for no more than one task. Employees are not to wrap or package leftover food using bare hands or unclean utensils. Hand sanitizers may be used after proper hand washing. Employees handling food must have fingernails that are trimmed, cleanable, and smooth. (113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f))

Inspector Comments:

-Observed employee holding container of whisked eggs by the rim, which had excessive raw eggs spill, and pouring onto flat grill to cook, then directly grabbed vegetables (green peppers, onions, and tomatoes) from pull out drawer with bare hands without proper handwash. Ensure employee properly wash hands in between tasks, especially between contacts of raw foods and ready to eat foods, to prevent possible cross contamination of food products.

NOTE:

-Per operator, vegetables used with eggs for omelets are only used for that purpose, and not for any other foods.

-Observed employee wash hands with one-time used gloves on at handwash sink. Ensure employee remove gloves and discard, before washing hands. Corrected on site.

Non-critical Violations

40: Wiping cloths: properly used and stored

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)

Inspector Comments: Observed chlorine sanitizer level at 0 ppm in sanitizer bucket at cook's line. Ensure sanitizer level remains between 100 ppm - 200 ppm for chlorine.

Violation Description: This facility is currently in violation with the food worker certification requirement for San Bernardino County, which states all food workers must obtain a valid food worker certificate within fourteen (14) days of employment (33.0410, 33.044). Failure to provide proof of food worker certification within fourteen (14) days will result in unannounced billable (at our current hourly rate) re-inspections to verify compliance.

Inspector Comments:

-Observed 1 expired food handler card. Obtain food handler cards through San Bernardino County website at www.sbcounty.gov/dehs and click on " Food Worker Training" link. Only food handler card obtained from San Bernardino County website is accepted.

NOTE:

-Food handler cards must be faxed to Department of Environmental Health Services within 14 days. Non-compliance will result in a charged inspection.
