Inspector Comments: Keep sanitizer bucket up front at all times; make up bucket prior to opening so when very busy, sanitizer bucket will be available.

43: Toilet facilities: properly constructed, supplied, cleaned

POINTS 1	Compliance date not specified	<i>Violation Description:</i> Toilet facilities shall be maintained clean, sanitary and in good repair. Toilet rooms shall be separated by a well-fitting self-closing door. Toilet tissue shall be provided in a permanently installed dispenser at each toilet. The number of toilet facilities shall be in accordance with local building and plumbing ordinances. Toilet facilities shall be provided for patrons: in establishments with more than 20,000 sq ft.; establishments offering on-site liquor consumption. (114250, 114250.1, 114276)

Inspector Comments: Check hot water to men's room; water pressure low so warm water takes almost one minute to come to faucet; increase pressure for men's room. NOTE: Ladies room received warm water earlier but since just tested after men's. Check ladies room hot water so it is received quicker than one minute. Increasing pressure should solve problem.

44: Premises: personal/cleaning items: vermin-proofing

POINTS 1	Compliance date not specified	<i>Violation Description:</i> The premises of each food facility shall be kept clean and free of litter and rubbish; all clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces; the facility shall be kept vermin proof. (114067 (j), 114123, 114143 (a) & (b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282) Food preparation sinks, handwashing sinks and warewashing equipment shall not be used for the cleaning of maintenance tools, the holding of maintenance materials, or the disposal of liquid wastes. (114123) Open-air barbecue and/or outdoor wood burning oven must operate on the same premises, in conjunction with a permanent food facility and not in an area that may pose as a fire hazard. (114143(a) (b)) Janitorial sink or approved curbed cleaning facility (exemption for restricted food service facilities Section 114279 (b)) shall be provided. (114279(a)) First aid supplies must have a legible manufacturer's label and stored in a kit or container that is located to prevent contamination. (114256.4) Insect electrocution devices are not allowed in food or utensil handling areas. (114259.3)

Inspector Comments: Store all items up off floor in small dry storage room; organize items you wish to keep. Good organization and keeping items up off floor will help detect any rodent problems. No rodent problem observed; only clean glue traps.

Automatic sanitizer dispenser is malfunctioning at this time and dispensing over 400 ppm QA sanitizer. Employees are diluting solution to 200-400 ppm correctly. Manager has called 800 number for repair and is waiting on call back. In the meantime, continue diluting so sanitizer is no stronger than 400 ppm maximum. Ensure sanitizer buckets are also diluted.

Good demonstration of knowledge by employee in sanitizing strength, temperatures, etc. Hair restraints worn by all. Good handwashing observed.
