4: Proper eating, tasting, drinking or tobacco use

Violation Description: Employees shall not eat, drink, or use tobacco in non-designated areas where contamination may result. (113977) An employee shall not use a utensil to taste food more than once without being properly washed, rinsed and sanitized between uses. (113976)

Inspector Comments: Observed open drinking cup on line ice machine; Use closed cups away from food and foodprep surfaces at all times.

6: Adequate handwashing facilities supplied & accessible

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

Inspector Comments: Observed the Staff Toilet room sink lacks paper towels; Keep sink stocked at all times.

7: Proper hot and cold holding temperatures

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

Inspector Comments: Observed PHF on top of line Coldpan units 47-48 degrees F; Maintain all Cold-Held PHF at 41 degrees F or below.

Inspector Comments: Observed the wire rack shelving and the beer kegs in the walk-in covered with white moldlike growths; Clean and sanitize.

Observed the side of the deep fryer coated with heavy grease and food splash; Clean area and maintain clean.

40: Wiping cloths: properly used and stored

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)

Inspector Comments: Observed wiping cloths left on counters; Keep in sanitizer solution when not in use.

48: Food Worker Certification

Violation Description: This facility is currently in violation with the food worker certification requirement for San Bernardino County, which states all food workers must obtain a valid food worker certificate within fourteen (14) days of employment (33.0410, 33.044). Failure to provide proof of food worker certification within fourteen (14) days will result in unannounced billable (at our current hourly rate) re-inspections to verify compliance.
