<b>POINTS</b> <b>2</b>	Compliance date not specified	<i>Violation Description:</i> All food contact surfaces of utensils and equipment shall be clean and sanitized. <i>Inspector Comments:</i> Excessive sanitizer levels(more than 400ppm) were observed in 3 compartment sink and in sanitizing buckets. Ensure that sanitizing solutions are maintained at 100ppm for chlorine and 200ppm for quaternary ammonia. Store wiping cloths in sanitizing solution in buckets prior to and after each use. Corrected during inspection.

<i>Inspector Comments:</i> Observed several open foods in the walk-in and reach-in refrigerators. Ensure that all stored foods are properly covered at all times.		

**34: Warewashing facilities: installed, maintained, used; test strips**

<b>POINTS</b> <b>1</b>	Compliance date not specified	<i>Violation Description:</i> Food facilities that prepare food shall be equipped with warewashing facilities. Testing equipment and materials shall be provided to measure the applicable sanitization method. (114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125) A thermometer must be readily available to monitor the temperature of the water at the warewashing sink. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.

<i>Inspector Comments:</i> Test strips to check quaternary ammonia sanitizer level were not available. Provide sanitizer test strips to check strength of quat sanitizer.

<i>Inspector Comments:</i> Observed slime buildup on the inside cover of the ice machine. Provide thorough and regular cleaning.		
Observed heavy grease buildup on the filters and the hood in the kitchen. Provide thorough cleaning.		
Observed old food scraps buildup on the can opener. Provide thorough cleaning.		

**36: Equipment, utensils and linens: storage and use**

**40: Wiping cloths: properly used and stored**

<b>POINTS</b> <b>1</b>	Compliance date not specified	<i>Violation Description:</i> Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)

**44: Premises; personal/cleaning items; vermin-proofing**

*Violation Description:* The premises of each food facility shall be kept clean and free of litter and rubbish; all clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces; the facility shall be kept vermin proof. (114067 (j), 114123, 114143 (a) & (b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282) Food preparation sinks, handwashing sinks and warewashing equipment shall not be used for the cleaning of maintenance tools, the holding of maintenance materials, or the disposal of liquid wastes. (114123) Open-air barbecue and/or outdoor wood burning oven must operate on the same premises, in conjunction with a permanent food facility and not in an area that may pose as a fire hazard. (114143(a) (b)) Janitorial sink or approved curbed cleaning facility (exemption for restricted food service facilities Section 114279 (b)) shall be provided. (114279(a)) First aid supplies must have a legible manufacturer's label and stored in a kit or container that is located to prevent contamination. (114256.4) Insect electrocution devices are not allowed in food or utensil handling areas. (114259.3)

*Inspector Comments:* Observed employee's clothing on prep table.  
 Provide a designated space for employee items.
