Non-critical Violations

4: Proper eating, tasting, drinking or tobacco use

Violation Description: Employees shall not eat, drink, or use tobacco in non-designated areas where contamination may result. (113977) An employee shall not use a utensil to taste food more than once without being properly washed, rinsed and sanitized between uses. (113976)

Inspector Comments: Observed an employee's OPEN drink sitting on the main prep table near the cash register. A food employee may drink from a CLOSED beverage container if the container is handled to prevent contamination of the employee's hands, the container, non-prepackaged food, and food contact surfaces. An employee's beverage container should not be placed on or directly above a food contact surface.

40: Wiping cloths: properly used and stored

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)

Inspector Comments: Observed the sanitizer level in a one sanitizer bucket and in the sanitizer compartment of the three compartment sink were well over 300ppm quat at the time of this inspection. This sanitizer is at a very high concentration coming straight out of the dispenser. Maintain sanitizer levels between 200-300ppm quat at all times where needed. Ensure the sanitizer level is correct at the dispenser or dilute as needed

44: Premises: personal/cleaning items; vermin-proofing

Violation Description: The premises of each food facility shall be kept clean and free of litter and rubbish; all clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces; the facility shall be kept vermin proof. (114067 (j), 114123, 114143 (a) & (b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282) Food preparation sinks, handwashing sinks and warewashing equipment shall not be used for the cleaning of maintenance tools, the holding of maintenance materials, or the disposal of liquid wastes. (114123) Open-air barbecue and/or outdoor wood burning oven must operate on the same premises, in conjunction with a permanent food facility and not in an area that may pose as a fire hazard. (114143(a) (b)) Janitorial sink or approved curbed cleaning facility (exemption for restricted food service facilities Section 114279 (b)) shall be provided. (114279(a)) First aid supplies must have a legible manufacturer's label and stored in a kit or container that is located to prevent contamination. (114256.4) Insect electrocution devices are not allowed in food or utensil handling areas. (114259.3)

Inspector Comments: Observed employee personal items stored co-mingled with dry storage food and food related items. Separate all food/food related items and personal items clearly and at all times.

Observed the air curtain at the back service door to be inoperable. Repair and maintain as needed.
