Violation Description: During your last routine inspection, it was noted that your facility was in violation of the food worker certification requirement for San Bernardino County. Since the inspection, food worker certification compliance has not been verified by Environmental Health staff. A billable reinspection has been conducted on this date to verify compliance.

Inspector Comments: Observed facility still not in compliance with all the food worker cards. Observed 1 card still missing. 4 previous missing food worker cards have been field verified by inspector.

Obtain current/active San Bernardino County food worker card immediately. Fax proof of completion to the number provided.

Failure to do so within 7 days will result in further CHARGED re-inspection at the rate of \$122.50/30 minutes.
