Inspector Comments: A charged inspection is conducted today as a follow up from a routine inspection on 2/5/13. It was noted on routine inspection report that 4 food worker cards were missing and/or expired. Upon inspection, employee was notified to contact owner and fax in roster of current active employees, and food worker verification form within 7 days. Failure to comply may result in another charged inspection at \$245 per hour.

During inspection person in charge filled up food worker verification form.

Violation Description: During your last routine inspection, it was noted that your facility was in violation of the food worker certification requirement for San Bernardino County. Since the inspection, food worker certification compliance has not been verified by Environmental Health staff. A billable reinspection has been conducted on this date to verify compliance.
