POINTS 1	Compliance date not specified	Inspector Comments: Measured the sanitizer concentration (chlorine) < 100 ppm . Maintain the concentration of sanitizer between 100-200 ppm.

Violation Description: Food facilities that prepare food shall be equipped with warewashing facilities. Testing equipment and materials shall be provided to measure the applicable sanitization method. (114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125) A thermometer must be readily available to monitor the temperature of the water at the warewashing sink. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.

POINTS 1	Compliance date not specified	Inspector Comments: Observed couple on in use cloth towels underneath the beer dispensers. Store all in use cloth towels in sanitizer bucket in between uses.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)
