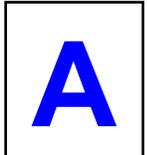

Ensure that employees know minimum cooking temperature for hamburger patty is 155F and 165F for chicken to prevent foodborne illness from occurring.

POINTS 2	Compliance date not specified	Inspector Comments: Observed several flies flying around kitchen and dining room area. Ensure that windows and doors are kept closed and air curtain turns on each time window or door is opened to prevent vermin from entering facility.

Violation Description: Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. (114259.4, 114259.5)

40. WIPING CLOTHS: PROPERLY USED AND STORED

POINTS 1	Compliance date not specified	Inspector Comments: Observed wet wiping cloth on counter. Ensure wiping cloths are returned to sanitizer bucket or discarded after each use to prevent bacterial growth.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)
