POINTS 2	Compliance date not specified	Inspector Comments: Observed the sanitizer in 2 compartments of the the 3-compartment sink, and rinse water in one while the manually warewashing of utensils. Ensure utensils are washed with soap and warm water (minimum 100F), rinsed, sanitized in an approved sanitizer, and then air-dried. One of the compartments of sanitizer was drained and filled with warm soap water for adequate manual warewashing procedures.
	Not In Compliance	
		Observed the warewashing machine dispenser chlorine sanitizer less than 10ppm. Ensure warewashing machine is in good repair. Maintain the chlorine sanitizer at a minimum of 50ppm in the warewashing machine. Operator stated dishes air-drying on the counter were taken through the machine. Ensure utensils are properly sanitized and air-dried prior to use.
