POINTS 2	Compliance date not specified	Inspector Comments: Observed hand soap inaccessible due to improper restocking of product in dispenser. Ensure that hand washing facilities are fully supplied, accessible and dispensing properly at all times. Corrected on site: Employee adjusted re-situated soap in dispenser.

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

30. FOOD STORAGE; FOOD STORAGE CONTAINERS IDENTIFIED

POINTS 1	Compliance date not specified	Inspector Comments: Observed trash bag hanging on side bar of dry storage rack in baking area. Ensure that all trash is separated from food storage areas. Observed open bulk bags of baking supplies (chocolate cake mix) in dry storage area. Ensure that all bulk products, once opened, are transferred to a container with a tight fitting lid.

Violation Description: Food shall be stored in approved containers and labeled as to contents. Food shall be stored at least 6" above the floor on approved shelving in an approved location to prevent possible contamination. (114047, 114049, 114051, 114053, 114055, 114067(h), 14069 (b))

POINTS 1	Compliance date not specified	Inspector Comments: Observed leak at 3 compartment sink faucet. Repair.

Violation Description: The potable water supply shall be protected with a backflow or back siphonage protection device, as required by applicable plumbing codes. (114192) All plumbing and plumbing fixtures shall be installed in compliance with local plumbing ordinances, shall be maintained so as to prevent any contamination, and shall be kept clean, fully operative, and in good repair. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose.
