**Inspector Comments:** Observed "B" letter grade moved to another location from where inspector had placed card. Letter grade was also facing inward towards the interior of facility. Ensure that letter grade is facing out and visible to public. Inspector reposted letter grade to be visible by public. DO NOT REMOVE, RELOCATE, HIDE OR ALTER LETTER GRADE. Failure to comply may result in charged inspection at \$245 per hour with a 30 minute minimum at \$122.50.

**Violation Description:** Handwashing signs shall be posted in each toilet room, directing attention to the need to thoroughly wash hands after using the restroom (113953.5) (b) No smoking signs shall be posted in food preparation, food storage, warewashing, and utensil storage areas (113978). (c) Consumers shall be notified that clean tableware is to be used when they return to self-service areas such as salad bars and buffets. (d) Any food facility constructed before January 1, 2004 without public toilet facilities, shall prominently post a sign within the food facility in a public area stating that toilet facilities are not provided (113725.1, 114381 (e)). A sign shall be posted stating that a copy of the most recent routine inspection report is available upon request. (113725.1) Permit shall be posted in conspicuous location. (114381(e)) Letter Grade Placecard shall be properly posted. SBCC 33.1406
