**Inspector Comments:** A charged inspection conducted today as a follow up from a routine inspection on May 13, 2013. It was stated on routine inspection report that 6 food worker cards were missing, invalid and/or expired. Until today, we have not received food worker cards. Upon today's inspection, 6 food worker cards still need to be verified. A 7 day extension will be given from today's date, May 28, 2013. Non-compliance may result in another charged inspection, office hearing and/or suspension of health permit.

**Violation Description:** During your last routine inspection, it was noted that your facility was in violation of the food worker certification requirement for San Bernardino County. Since the inspection, food worker certification compliance has not been verified by Environmental Health staff. A billable reinspection has been conducted on this date to verify compliance.
