Inspector Comments:

-A follow-up inspection was conducted at facility regarding roach infestation throughout kitchen area.

-Upon inspection, observed the following:

1. A live roach on the wall above ice machine.
2. A dead roach stuck inside ice in ice machine. Clean and sanitize ice machine before use and maintain.
3. About 4 - 6 half live/dead roach behind refrigerators at cook's line, under prep sink, ice machine, and stove (next to oven). Clean all areas affected by roach activity and maintain.

Observed pest control service conducted on 05/29/13.

-Facility is ordered to be closed due to live roach activity in the above mentioned areas. DO NOT OPEN UNTIL AUTHORIZED BY DIVISION OF ENVIRONMENTAL HEALTH SERVICES (DEHS). Non-compliance will result in future charged inspections at \$245.00/hour.

Violation Description: Reinspection conducted at this time to determine compliance from prior inspection.
