Inspector Comments: Observed fruit flies inside 6 liquor bottles. Discarded liquor bottles. Prevent potential adulteration by covering liquor bottles properly and eliminate further infestation.

Remove ice from inside ice machine. Ice has been exposed to dust and shall be discarded.

Violation Description: All food shall be manufactured, produces, prepared, compounded, packed, transported, kept for sale, and served so as to be pure and free from adulteration and spoilage. Any food is adulterated if it bears or contains any poisonous or deleterious substance that may render it impure or injurious to health. (113967, 113976, 113980, 113988, 113990, 114035, 114254(c), 114254.3)

Clean/maintain soda gun and ice machine. Observed exposed to dust build-up.

34. WAREWASHING FACILITIES: INSTALLED, MAINTAINED, USED; TEST STRIPS

Inspector Comments: Obtain approved test strips to measure adequate sanitizer levels. Facility stated that Ammonia sanitizer will be used, however, chlorine test strips were observed. If Ammonia is used, keep concentration at 200 ppm at all times. If chlorine is used, keep concentration at 100 ppm at all times.

Violation Description: Food facilities that prepare food shall be equipped with warewashing facilities. Testing equipment and materials shall be provided to measure the applicable sanitization method. (114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125) A thermometer must be readily available to monitor the temperature of the water at the warewashing sink. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.

41. PLUMBING; PROPER BACKFLOW DEVICES

Inspector Comments: Raise pipe of ice machine at least 1 inch above floor sink to prevent potential backflow contamination.

Violation Description: The potable water supply shall be protected with a backflow or back siphonage protection device, as required by applicable plumbing codes. (114192) All plumbing and plumbing fixtures shall be installed in compliance with local plumbing ordinances, shall be maintained so as to prevent any contamination, and shall be kept clean, fully operative, and in good repair. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. (114171, 114189.1, 114190, 114193, 114193.1, 114199, 114201, 114269)

45. FLOORS, WALLS AND CEILINGS: BUILT, MAINTAINED, AND CLEAN

Inspector Comments: Repair floors in bar area. Observed several cracks.

Repair floors in restroom with one of the following:

- A continuous vinyl sheet that extends at least 4 inches for the base cove.
- Ceramic tiles with slim foot tile for base cove.
- Concrete floor with an epoxy finish and slim foot tile for the base cove.

Ensure that all walls in restrooms have FRP that is at least 4 feet in height.

Violation Description: The walls / ceilings shall have durable, smooth, nonabsorbent, and washable surfaces. All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable. (114272) Open-air barbecues or wood-burning ovens floor surfaces must extend a minimum of five feet and be impervious or easily cleanable. (114143(d))
